20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 15. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA HELP. No employee of the Camp J.T. Robinson, or Fort Chaffee Federal Training Site Divisions of the Military Department who is employed as "extra

1 help” may receive an amount to exceed eighty-five percent (85%) of the
2 maximum annual salary for a comparable position as authorized under Arkansas
3 Code 21-5-201 et seq. during any fiscal year, nor shall such employee be
4 employed for a period of time to exceed eighteen hundred (1800) hours in any
5 single fiscal year.

6 The provisions of this section shall be in effect only from July 1, ~~2018~~
7 2019 through June 30, ~~2019~~ 2020.

9 SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CAMP
11 ROBINSON - VARIOUS STATE MILITARY LAKES. The State Military Department is
12 hereby authorized to stock various State Military Lakes on Camp Robinson post
13 each year with fish for special events by using wildlife funds and rental
14 income, no State General Revenue will be used.

15 The provisions of this section shall be in effect only from July 1, ~~2018~~

18 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. GENERALS
20 SALARY. The line item maximums for the State of Arkansas Adjutant General and
21 Deputy Adjutant General are based on the salary grid by the United States
22 Department of Defense. Incumbents in these positions shall be compensated in
23 accordance with the Department of Defense Advisory Service Pay Plan and are
24 not guaranteed placement at the maximum level. The line item maximum
25 salaries may be adjusted on July 1 of each fiscal year to incorporate salary
26 rate changes that have been implemented by the U.S. Department of Defense.

27 The provisions of this section shall be in effect only from July 1, ~~2018~~
28 2019 through June 30, ~~2019~~ 2020.

29
30 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
31 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
32 PROMOTIONAL ITEMS. The State Military Department is hereby authorized to
33 transfer appropriation from Operating Expenses to Promotional Items in the
34 General Operations Appropriation and/or Cash Operations Appropriation
35 provided by this Act in an amount not to exceed ten thousand dollars
36 (\$10,000) each fiscal year, as authorized by the Director of State Resources,

1 and with the approval of the Chief Fiscal Officer of the State.

2 The provisions of this section shall be in effect only from July 1,
3 2019 through June 30, 2020.

4
5 SECTION 19. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
6 authorized by this act shall be limited to the appropriation for such agency
7 and funds made available by law for the support of such appropriations; and
8 the restrictions of the State Procurement Law, the General Accounting and
9 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
10 Procedures and Restrictions Act, or their successors, and other fiscal
11 control laws of this State, where applicable, and regulations promulgated by
12 the Department of Finance and Administration, as authorized by law, shall be
13 strictly complied with in disbursement of said funds.

14
15 SECTION 20. LEGISLATIVE INTENT. It is the intent of the General
16 Assembly that any funds disbursed under the authority of the appropriations
17 contained in this act shall be in compliance with the stated reasons for
18 which this act was adopted, as evidenced by the Agency Requests, Executive
19 Recommendations and Legislative Recommendations contained in the budget
20 manuals prepared by the Department of Finance and Administration, letters, or
21 summarized oral testimony in the official minutes of the Arkansas Legislative
22 Council or Joint Budget Committee which relate to its passage and adoption.

23
24 SECTION 21. EMERGENCY CLAUSE. It is found and determined by the
25 General Assembly, that the Constitution of the State of Arkansas prohibits
26 the appropriation of funds for more than a one (1) year period; that the
27 effectiveness of this Act on July 1, 2019 is essential to the operation of
28 the agency for which the appropriations in this Act are provided, and that in
29 the event of an extension of the legislative session, the delay in the
30 effective date of this Act beyond July 1, 2019 could work irreparable harm
31 upon the proper administration and provision of essential governmental
32 programs. Therefore, an emergency is hereby declared to exist and this Act
33 being necessary for the immediate preservation of the public peace, health
34 and safety shall be in full force and effect from and after July 1, 2019.
