SECTION 1. Arkansas Code § 27-24-1404(c)(1), concerning the application process for a special license plate decal and special license plate, is amended to read as follows:

(c)(1)(A) If the request is approved, the director shall determine:

(i) The fee for the cost of creating a special license plate, including without limitation the cost of:
(a) The initial order of a special license plate created under this subchapter ~~initial orders of new designs for special license plates which shall be based on the cost of initial orders of new designs for special license plates;~~

(b) Creating a new design for a special license plate and any subsequent revisions to the design;

(c) The computer programming and testing required to add a special license plate to the Department of Finance Administration's computer system;



1 (d) Maintaining the computer system required
2 under subdivision (c)(1)(A)(i)(c) of this section; and

3 (e) Shipping and distributing a special
4 license plate created under this subchapter to all revenue offices in the
5 state;

6 (ii) The number of applications that must be
7 received to cover the ~~cost of the initial orders of new designs for special~~
8 ~~license plates~~ costs provided in subdivision (c)(1)(A)(i) of this section; or

9 (iii) The combination of subdivisions (c)(1)(A)(i)
10 and (ii) of this section that must be received ~~to cover the cost of the~~
11 ~~initial orders of new designs for special license plates~~ by the department
12 for the creation of a special license plate.

13 (B)(i) *The fee remitted under subdivision (c)(1)(A) of*
14 *this section shall be deposited into the State Central Services Fund for the*
15 *benefit of the Revenue Division of the Department of Finance and*
16 *Administration.*

17 (ii) *The fee shall be credited as supplemental and*
18 *in addition to all other funds as may be deposited for the benefit of the*
19 *division.*

20 (iii) *The fee shall not be considered or credited to*
21 *the division as direct revenue.*

22 (C) The fee required under subdivision (c)(1)(A) of this
23 section does not apply to a special license plate in existence before January
24 1, 2019.
