## For An Act To Be Entitled

AN ACT TO MAKE AN APPROPRIATION FOR OPERATING  
EXPENSES FOR THE ARKANSAS NORTHEASTERN COLLEGE WHICH  
SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
APPROPRIATED BY ACT 179 OF 2018; AND FOR OTHER  
PURPOSES.

## Subtitle

AN ACT FOR THE ARKANSAS NORTHEASTERN  
COLLEGE SUPPLEMENTAL APPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby  
appropriated, to the Arkansas Northeastern College, to be payable from the  
Arkansas Northeastern College Fund, for operating expenses of the Arkansas  
Northeastern College which shall be supplemental and in addition to those  
funds appropriated in Section 3 of Act 179 of 2018, the following:

2 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
3 authorized by this act shall be limited to the appropriation for such agency  
4 and funds made available by law for the support of such appropriations; and  
5 the restrictions of the State Procurement Law, the General Accounting and  
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
7 Procedures and Restrictions Act, the Higher Education Expenditures  
8 Restrictions Act, or their successors, and other fiscal control laws of this  
9 State, where applicable, and regulations promulgated by the Department of  
10 Finance and Administration, as authorized by law, shall be strictly complied  
11 with in disbursement of said funds.

13 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General  
14 Assembly that any funds disbursed under the authority of the appropriations  
15 contained in this act shall be in compliance with the stated reasons for  
16 which this act was adopted, as evidenced by the Agency Requests, Executive  
17 Recommendations and Legislative Recommendations contained in the budget  
18 manuals prepared by the Department of Finance and Administration, letters, or  
19 summarized oral testimony in the official minutes of the Arkansas Legislative  
20 Council or Joint Budget Committee which relate to its passage and adoption.

22 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
23 Assembly, that funds provided by the General Assembly for the operations of  
24 the Arkansas Northeastern College are, due to unforeseen circumstances,  
25 insufficient for the Arkansas Northeastern College to continue to provide  
26 essential governmental services; that the provisions of this act will provide  
27 the necessary monies for the Arkansas Northeastern College to continue such  
28 services; and that a delay in the effective date of this Act could work  
29 irreparable harm upon the proper administration and provision of essential  
30 governmental programs. Therefore, an emergency is hereby declared to exist  
31 and this Act being necessary for the immediate preservation of the public  
32 peace, health and safety shall be in full force and effect from and after the  
33 date of its passage and approval.

34 If the bill is neither approved nor vetoed by the Governor, it shall  
35 become effective on the expiration of the period of time during which the  
36 Governor may veto the bill. If the bill is vetoed by the Governor and the

veto is overridden, it shall become effective on the date the last house  
overrides the veto.
