24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. Arkansas Code § 21-6-203 is amended to read as follows:
27 21-6-203. Commissioner of State Lands.

28 ~~(a) The following fees shall be charged and collected by the~~
29 ~~Commissioner of State Lands:~~

30 ~~(1) Emerged Land Deeds issued pursuant to §§ 22-5-404, 22-5-405~~

13 (b) ~~The Commissioner of State Lands shall charge a collection fee of~~
 14 ~~twenty-five dollars (\$25.00) against all tax delinquent land redeemed or sold~~
 15 ~~by the Commissioner of State Lands, except the fees charged for the~~
 16 ~~redemption of severed mineral interests shall not include the twenty-five-~~
 17 ~~dollar collection fee.~~

18 (c) ~~For each certificate of donation to forfeited lands issued by the~~
 19 ~~Commissioner of State Lands, there shall be paid a fee of ten dollars~~
 20 ~~(\$10.00).~~

21 (d) ~~For each donation deed issued by the Commissioner of State Lands,~~
 22 ~~there shall be paid a fee of one dollar (\$1.00).~~

23 (a) The Commissioner of State Lands may by rule:

24 (1) Establish a schedule of rates, fees, and charges for the
 25 deeds produced and filed or services performed in carrying out the
 26 established duties and authority of the office of the Commissioner of State
 27 Lands; and

28 (2) Revise the rates, fees, and charges to ensure that the
 29 revenues from the rates, fees, and charges together with other available
 30 funds shall be sufficient to cover the costs of the various deeds produced or
 31 filed and services performed in carrying out the established duties and
 32 authority of the office.

33 (e)(b) A fee under this section shall not be established in an amount
 34 that exceeds three percent (3%) of the actual costs expended by the
 35 Commissioner of State Lands in producing or filing deeds or performing
 36 services.

1 (c) All rates, fees, and charges collected by the Commissioner of
 2 State Lands shall be deposited into a financial institution in the state.

 4 SECTION 2. Arkansas Code § 26-37-105 is amended to read as follows:
 5 26-37-105. Collection fee.

6 (a) The Commissioner of State Lands ~~shall~~ may charge a ~~twenty-five~~
 7 ~~dollar (\$25.00)~~ collection fee for each deed issued by the Commissioner of
 8 State Lands, whether the land is redeemed or sold.

9 (b) The fee under this section shall be established by rule adopted by
 10 the Commissioner of State Lands.

11 (c) However, the fee under this section shall not exceed three percent
 12 (3%) of the actual costs expended by the Commissioner of State Lands in
 13 producing, filing, or performing the deed.

 15 SECTION 3. Arkansas Code § 26-37-201(a)(2), concerning fees to recover
 16 the costs of publication of the notice, is amended to read as follows:

17 (2)(A) The publication fee for the notice shall be ~~the same as~~
 18 ~~set forth in § 26-37-107~~ adopted by rule of the Commissioner of State Lands.

19 (B) However, the fee under this section shall not exceed
 20 three percent (3%) of the actual costs expended by the Commissioner of State
 21 Lands in producing, filing, or performing the redemption deed.
