6	SECTION 2. Arkansas Code § 26-37-105 is amended to read as follows:
7	26-37-105. Collection fee.
8	(a) The Commissioner of State Lands shall may charge a twenty five
9	dollar (\$25.00) collection fee for each deed issued by the Commissioner of
10	State Lands, whether the land is redeemed or sold.
11	(b) The collection fee under this section shall be established by rule
12	adopted by the Commissioner of State Lands.
13	(c) However, the collection fee under this section shall not exceed
14	the costs expended by the Commissioner of State Lands in producing or filing
15	the deed.
16	(2) As used in subdivision (c)(1) of this section, "costs" means
17	the actual costs expended by the Commissioner of State Lands plus three
18	percent (3%) of the actual costs expended by the Commissioner of State Lands.
19	
20	SECTION 3. Arkansas Code § 26-37-201(a)(2), concerning fees to recover
21	the costs of publication of the notice, is amended to read as follows:
22	(2) $\underline{(A)}$ The publication fee for the notice shall be the same as
23	set forth in § 26-37-107 adopted by rule of the Commissioner of State Lands.
24	(B)(i) However, the fee under this section shall not
25	exceed the costs expended by the Commissioner of State Lands in producing,
26	filing, or performing the deed.
27	(ii) As used in subdivision (a)(2)(B)(i) of this section,
28	"costs" means the actual costs expended by the Commissioner of State Lands
29	plus three percent (3%) of the actual costs expended by the Commissioner of
30	State Lands.
