27	"home-brewed", is ame	nded to read as follows:	
28	(5)(A) <del>"</del>	Home-brewed" "Home-brewed beer" means b	eer <u>,</u> <del>made from</del>
29	malted barley, wheat,	or cereal grains, or any substitute th	erefor, and
30	having an alcoholic c	ontent not in excess of five percent (5	%) by weight,
31	brewed for consumptio	n by the manufacturer and his or her fa	mily and guests,
32	but not for sale ale,	porter, stout, and other similar ferme	<u>nted beverages</u>
33	containing one-half o	f one percent (0.5%) or more of alcohol	by volume brewed

1	SECTION 2. Arkansas Code § 3-5-205(f)(1), concerning the exception to
2	the privilege tax for a manufacturer of home-brewed beer, is amended to add
3	an additional subdivision to read as follows:
4	(D) Home-brewed beer may be removed from the
5	manufacturer's premises for personal or family use, including without
6	limitation, for organized affairs, exhibitions, competitions, and tastings.
