24 The provisions of this section shall be in effect only from July 1, 2018
25 <u>2019</u> through June 30, 2019 <u>2020</u>.

27 SECTION 33. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REPORTING 29 REQUIREMENTS. The Arkansas Forestry Commission shall present the following 30 data each month to the Chief Fiscal Officer of the State and the Arkansas 31 Legislative Council or Joint Budget Committee. This report shall be due by 32 the 10th day of the month following the reporting period. The first reporting 33 period shall be July 2012.

a) All fund transfers completed by the Arkansas Forestry Commission from
any funding source including federal funds, and shall include a justification
for the completion of the fund transfers.

b) All expenditures incurred by the Arkansas Forestry Commission from
 any funding source including federal funds, and shall include a justification
 for the expenditure of the funds.

c) All revenue receipts of the Arkansas Forestry Commission including
but not limited to federal funds, general revenue, severance tax, acreage
tax, timber sales and seedlings sales.

d) All Arkansas Forestry Commission activities including but not limited
to, firefighting activities, fire prevention, and emergency response as it
relates to the Commission's statutory mission provided in Arkansas Code 1531-101.

The provisions of this section shall be in effect only from July 1, 2018
 2019 through June 30, 2019 2020.

14 SECTION 34. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. 16 PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall establish 17 upon request for the Arkansas Agriculture Department a special Promotional 18 Items appropriation to be used in the acquisition of promotional items. 19 When the Arkansas Agriculture Department wishes to transfer from its 20 operating expenses to the promotional items line, the request shall be 21 forwarded by the Arkansas Agriculture Department to the Chief Fiscal Officer 22 of the State for processing and for prior approval by the Arkansas 23 Legislative Council or Joint Budget Committee. Determining the maximum 24 number of employees and the maximum amount of appropriation and general 25 revenue funding for a state agency each fiscal year is the prerogative of the 26 General Assembly. This is usually accomplished by delineating such maximums 27 in the appropriation act(s) for a state agency and the general revenue 28 allocations authorized for each fund and fund account by amendment to the 29 Revenue Stabilization law. Further, the General Assembly has determined that 30 the Arkansas Agriculture Department may operate more efficiently if some 31 flexibility is provided to the Arkansas Agriculture Department authorizing 32 broad powers under this Section. Therefore, it is both necessary and 33 appropriate that the General Assembly maintain oversight by requiring prior 34 approval of the Legislative Council or Joint Budget Committee as provided by 35 this section. The requirement of approval by the Legislative Council or 36 Joint Budget Committee is not a severable part of this section. If the

1 requirement of approval by the Legislative Council or Joint Budget Committee
2 is ruled unconstitutional by a court of competent jurisdiction, this entire
3 section is void.

4 The provisions of this section shall be in effect only from July 1, 2018

7 SECTION 35. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 8 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SHARED 9 SERVICES. The Chief Fiscal Officer of the State shall be authorized to create 10 paying accounts, on his or her books and on the books of the Treasurer of the 11 State and Auditor of State for the payment of all personal services and 12 operating expenses of the Department, as well as grant programs as determined 13 by the Secretary of the Arkansas Agriculture Department. The Chief Fiscal 14 Officer of the state shall direct the transfer of positions, funds and 15 appropriations to the paying accounts on the books of the Treasurer of State, 16 the Auditor of State, and the Chief Fiscal Officer of the State for the 17 efficient operations of the Department.

18 The provisions of this section shall be in effect only from July 1, 2018
19 2019 through June 30, 2019 2020.

21 SECTION 36. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FAIR 23 WAIVER. The Arkansas Livestock and Poultry Commission shall waive the rules 24 under Section (2) of the Commission's Minimum Standards for Receiving Funds 25 for Premium and Construction Purposes to allow the Three-County Fair, 26 consisting of Cross, Woodruff, and Jackson counties, to hold the Three-County 27 Fair after the district fair while receiving the funds from the commission 28 that the Three-County Fair would receive if the fair were held before the 29 district fair.

The provisions of this section shall be in effect only from July 1, 2018 2019
through June 30, 2019 2020.

33 SECTION 37. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 34 authorized by this act shall be limited to the appropriation for such agency 35 and funds made available by law for the support of such appropriations; and 36 the restrictions of the State Procurement Law, the General Accounting and

Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 Procedures and Restrictions Act, or their successors, and other fiscal
 control laws of this State, where applicable, and regulations promulgated by
 the Department of Finance and Administration, as authorized by law, shall be
 strictly complied with in disbursement of said funds.

7 SECTION 38. LEGISLATIVE INTENT. It is the intent of the General 8 Assembly that any funds disbursed under the authority of the appropriations 9 contained in this act shall be in compliance with the stated reasons for 10 which this act was adopted, as evidenced by the Agency Requests, Executive 11 Recommendations and Legislative Recommendations contained in the budget 12 manuals prepared by the Department of Finance and Administration, letters, or 13 summarized oral testimony in the official minutes of the Arkansas Legislative 14 Council or Joint Budget Committee which relate to its passage and adoption. 15

16 SECTION 39. EMERGENCY CLAUSE. It is found and determined by the 17 General Assembly, that the Constitution of the State of Arkansas prohibits 18 the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2019 is essential to the operation of 19 20 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the 21 22 effective date of this Act beyond July 1, 2019 could work irreparable harm 23 upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act 24 25 being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2019. 26 27 28 29 */s/Joint Budget Committee* 30 31 32 33 34
