23	payable in equal monthly installments.

25	or future members of the General Assembly, or their beneficiaries, who meet

(a) Any member of the General Assembly or a state constitutional 16 17 officer who dies before completing a term of office to which the person was 18 elected shall continue to accrue credited service in the Arkansas Public 19 Employees' Retirement System during the remainder of the term for which the 20 person was elected. 21 (b) The surviving spouse of a member or former member of the General 22 Assembly or of a state constitutional officer or former state constitutional officer who, by virtue of the provisions of this section or any other law, 23 has five (5) years or more of credited service in any capacity in the system, 24 except for a member of the General Assembly who must have had ten (10) or 25 26 more years of credited service if he or she only has service as a member of 27 the General Assembly, shall be entitled upon reaching the required age to a 28 surviving spouse benefit in the amount prescribed by law under the division of the system in which the deceased member was receiving benefits or would 29 have been entitled under this section to receive benefits if the member had 30 31 lived to retirement age. 32 (c) Nothing contained in this section is intended to, nor shall 33 anything in this section be construed to, permit any member or former member of the General Assembly or any constitutional officer or former 34 constitutional officer or any spouse of the member or officer to earn 35

Contributory Governor. 5 (a)(1) Any person who serves two (2) full two year terms as Governor 6 or who substantially serves two (2) terms as Governor with the exception of 7 completing a portion or all of the last month of the second term by reason of 8 vacating the office solely for the purpose of taking another office to which 9 the person is elected and who accumulates not less than three (3) years and eleven (11) months of credited service under the Arkansas Public Employees' 10 11 Retirement System may retire upon reaching fifty-five (55) years of age under 12 the provisions of the system with an annuity equal to eighteen percent (18%) of the biennial salary prescribed for the Governor. 13 14 (2) Any person who serves as Governor for three (3) full two-15 year terms and who accumulates not less than six (6) years of credited service as a member of the system may retire upon reaching fifty-five (55) 16 17 years of age, under the provisions of the system with an annuity equal to 18 twenty-four percent (24%) of the biennial salary prescribed for the Governor. 19 (3) Any person who serves as Governor for four (4) or more twoyear terms and accumulates not less than eight (8) years of credited service 20 as a member of the system may retire, upon reaching fifty-five (55) years of 21 22 age, under the provisions of the system with an annuity equal to thirty 23 percent (30%) of the biennial salary prescribed for the Governor. 24 (b)(1) Any person who served as Governor prior to July 1, 1957, may, for the purpose of obtaining benefits under this section, purchase service 25 26 credit in the system for the period of years which the person served as 27 Governor by paying into the system an amount equal to five percent (5%) of 28 his or her salary received as Governor during his or her service, plus an equal amount as the employer contribution to the system, plus interest at the 29 30 rate of three percent (3%) per annum. 31 (2) Any person who served as Covernor after July 1, 1957, but 32 who has withdrawn his or her contributions to the system may, for purposes of 33 obtaining benefits under the provisions of this section, repay to the system the amount so withdrawn with interest thereon at the rate of three percent 34 35 (3%) from the date withdrawn to the date of repayment.

Elected contributory state constitutional officers 18 generally. 19 (a)(1)(A) Any elected state constitutional officer who as a member of 20 the Arkansas Public Employees' Retirement System accumulates not less than ten (10) years of credited service as an elected state constitutional officer 21 22 member of the system may voluntarily retire upon attaining age sixty (60) and receive an annuity provided in this section upon written application filed 23 with the Board of Trustees of the Arkansas Public Employees' Retirement 24 25 System. 26 (B) This application shall set forth at what time, not 27 less than thirty (30) days nor more than ninety (90) days subsequent to the 28 execution and filing thereof, the member desires to be retired. (2)(A) Any elected state constitutional officer who as a member 29 30 of the system accumulates not less than fourteen (14) years of credited service as an elected state constitutional officer and is a member of the 31 32 system may voluntarily retire upon attaining age fifty five (55) and receive 33 an annuity provided in this section upon his or her written application filed with the board. 34 35 (B) The application shall set forth at what time, not less than thirty (30) days nor more than ninety (90) days subsequent to the 36

- execution and filing thereof, the member desires to be retired.
- (b) The benefits of an elected state constitutional officer shall be not less than sixty-five percent (65%) of the biennial salary, but if the salaries of elected state constitutional officers are altered, benefits provided in this section shall be computed and determined on the basis of salaries in effect for such officers on January 1, 1976.
- (c)(1) If the contribution of the elected state constitutional officer member and the employer contributions are insufficient to pay the benefits of the elected state constitutional officer members, then, in that event, the board shall annually certify to the Chief Fiscal Officer of the State the amount sufficient to pay the deficit, based upon an actuarial determination of the additional amounts required to pay benefits of elected state constitutional officer members.
- (2) The Chief Fiscal Officer of the State shall cause the amount so certified to be transferred from the Constitutional Officers Fund and the State Central Services Fund to the system.
- (d) As used in this section, "elected state constitutional officer"
 means the Lieutenant Governor, Attorney General, Secretary of State, Auditor
 of State, Treasurer of State, and Commissioner of State Lands.
- (e) Nothing in this section shall prohibit the Lieutenant Governor from exercising any option provided by law to participate in benefits provided members of the General Assembly. In the event an elected state constitutional officer does not qualify for benefits provided elected state constitutional officers under the provisions of this section, the officer shall be entitled to benefits provided to other members of the system for which he or she is qualified, in terms of age and service, as provided by law.

- 30 <u>24-4-726. State penitentiary employees.</u>
 - (a)(1) Any member of the former Arkansas State Penitentiary Employees' Retirement System, as created by Acts 1957, No. 64 [repealed], may, after November 6, 1965, upon application and submission of proper proof to the Board of Trustees of the Arkansas Public Employees' Retirement System, become
- 35 members of the Arkansas Public Employees' Retirement System.
- 36 (2) That member may receive credit for all services rendered the

- state penitentiary upon paying, or causing to be paid, on or before November
 6, 1966, into the members' deposit account, the contributions he or she would
 have paid, together with three percent (3%) compound interest, had he or she
 been a member of the Arkansas Public Employees' Retirement System during his
 or her period of employment with the state penitentiary.
- 6 (b) Upon certification from the Executive Director of the Arkansas
 7 Public Employees' Retirement System, the Treasurer of State shall transfer
 8 from the Department of Correction Inmate Care and Custody Fund Account of the
 9 State General Government Fund to the Arkansas Public Employees' Retirement
 10 System Fund an amount equal to the contributions made by the state
 11 penitentiary employees. That amount shall be credited to the Employer
 12 Contribution Fund of the system.
 - (e) Upon becoming a member of the Arkansas Public Employees'
 Retirement System, the member shall be entitled to the same rights and
 privileges as other members of the Arkansas Public Employees' Retirement
 System.

- (d) The Board of Trustees of the Arkansas Public Employees' Retirement System is directed to make such rules and regulations as, in its opinion, will effect an orderly transfer of membership and service credits as provided in this section.
 - (e) All persons in receipt of a straight life annuity from the former Arkansas State Penitentiary Employees' Retirement System shall be transferred to the retirement rolls of the Arkansas Public Employees' Retirement System on January 1, 1970, and their monthly benefits shall be continued for the remainder of their natural lives.
- (f) On January 1 of each year, the Executive Director of the Arkansas Public Employees' Retirement System shall determine the amount necessary for the purpose of providing funds to assure the payment of such benefits. The Treasurer of State shall transfer from the Department of Correction Inmate Care and Custody Fund Account of the State General Government Fund to the Arkansas Public Employees' Retirement System Fund that amount, as certified by the executive director.
- 34 SECTION 11. Arkansas Code § 24-4-741 is repealed.
- 35 <u>24-4-741. Credit for service in reciprocal system.</u>
- 36 Notwithstanding the provisions of § 24-4-510 regarding total credited

1 service in reciprocal retirement systems, both service in the Arkansas Public 2 Employees' Retirement System as a member of the Arkansas State Claims 3 Commission and service in another reciprocal system during the same period of 4 time may be counted as credited service to meet the service requirements for 5 benefits from the Arkansas Public Employees' Retirement System and another 6 reciprocal system, subject to the following: 7 (1) The provisions of § 24-4-521 may not be used to meet the 8 minimum service requirements; 9 (2) The portion of service credit attributed under the 10 provisions of this section shall not be used to determine a member's 11 retirement eligibility or the member's normal retirement age under § 24-4-101; 12 13 (3) The benefit payable by a reciprocal system will be based on 14 the credited service in that system and on the final average compensation 15 under that system; and 16 (4) If a member has less than five (5) actual years of service 17 credited in a reciprocal system, then "final average compensation" means the 18 monthly average of pay to the member during his or her total years of service 19 in that system. 20 21 SECTION 12. Arkansas Code § 24-4-804(c)(1), the cessation of 22 participation in the Deferred Retirement Option Plan under the Arkansas 23 Public Employees' Retirement System, is amended to read as follows: 24 (c)(1) When a member's participation in the Arkansas Public Employees' 25 Retirement System Deferred Retirement Option Plan ceases, that member is not 26 eligible for employment in any position covered by the plans identified in § 27 24-2-401(3), except as provided for in § 24-4-520 unless the separation period would prevent a popularly elected official from taking or holding 28 29 office. 30 SECTION 13. EMERGENCY CLAUSE. It is found and determined by the 31 32 General Assembly of the State of Arkansas that the operations of the Arkansas 33 Public Employees' Retirement System must be able to meet the needs of its 34 members as anticipated by the General Assembly; that certain provisions of the system are in imminent need of revision; and that this act is immediately 35 36 necessary in order to maintain an orderly system of benefits for the members

1	of the system. Therefore, an emergency is declared to exist, and this act			
2	being immediately necessary for the preservation of the public peace, health			
3	and safety shall become effective on:			
4	(1) The date of its approval by the Governor;			
5	(2) If the bill is neither approved nor vetoed by the Governor,			
6	the expiration of the period of time during which the Governor may veto the			
7	bill; or			
8	(3) If the bill is vetoed by the Governor and the veto is			
9	overridden, the date the last house overrides the veto.
