## For An Act To Be Entitled

AN ACT TO REAPPROPRIATE THE BALANCES OF CAPITAL  
IMPROVEMENT APPROPRIATIONS FOR THE ARKANSAS  
AGRICULTURE DEPARTMENT; AND FOR OTHER PURPOSES.

## Subtitle

AN ACT FOR THE ARKANSAS AGRICULTURE  
DEPARTMENT REAPPROPRIATION.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

### SECTION 1. REAPPROPRIATION - DEVELOPMENT AND ENHANCEMENT FUND PROJECTS.

There is hereby appropriated, to the Arkansas Agriculture Department, to be payable from the Development and Enhancement Fund, for the Arkansas Agriculture Department the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (A) of Section 1 of Act 39 of 2018, for various maintenance, renovation, equipping, professional services contracts for air tankers, construction, acquisition, improvement, upgrade, and repair of real property and facilities, personal services and operational expenses related to agricultural disasters, in a sum not to exceed .....\$18,690.

(B) Effective July 1, 2019, the balance of the appropriation provided in Item (B) of Section 1 of Act 39 of 2018, for various maintenance, renovation, equipping, professional services contracts for air tankers, construction, acquisition, improvement, upgrade, and repair of real property and facilities, in a sum not to exceed .....\$22,210.

(C) Effective July 1, 2019, the balance of the appropriation provided in Item (C) of Section 1 of Act 39 of 2018, for various maintenance,



renovation, equipping, professional services contracts for air tankers, construction, acquisition, improvement, upgrade, repair of real property and facilities, personal services and operational expenses related to agricultural disasters, in a sum not to exceed .....\$10,000,000.

(D) Effective July 1, 2019, the balance of the appropriation provided in Item (E) of Section 1 of Act 39 of 2018, for various maintenance, renovation, equipping, professional services contracts for air tankers, construction, acquisition, improvement, upgrade, and repair of real property and facilities of the Arkansas Agriculture Department, in a sum not to exceed .....\$10,000,000.

(E) Effective July 1, 2019, the balance of the appropriation provided in Item (F) of Section 1 of Act 39 of 2018, for construction of New Office Space, Laboratories and Support Facilities for the Department of Agriculture, in a sum not to exceed .....\$6,000,000.

(F) Effective July 1, 2019, the balance of the appropriation provided in Item (D) of Section 1 of Act 39 of 2018, for grants for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities relating to County and District Fairs, in a sum not to exceed .....\$847,200.

(G) Effective July 1, 2019, the balance of the appropriation provided in Item (G) of Section 1 of Act 39 of 2018, for a grant or low interest loan for the Arkansas Agriculture Department - Plant Board to pay for debts associated with the Boll Weevil Suppression and Eradication Act, in a sum not to exceed .....\$13,800,000.

SECTION 2. REAPPROPRIATION - NECROPSY ROOM IMPROVEMENTS. There is hereby appropriated, to the Arkansas Agriculture Department, to be payable from the Livestock and Poultry Special Revenue Fund, for the Arkansas Agriculture Department the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in Item (A) of Section 2 of Act 39 of 2018, for construction, renovation and equipping of the Necropsy Room at the Livestock and Poultry Diagnostic Lab, in a sum not to exceed .....\$69,563.

SECTION 3. REAPPROPRIATION - BOND PROCEEDS CAPITAL PROJECTS. There is hereby appropriated, to the Arkansas Agriculture Department, to be payable

1 from the Bond Proceeds, for the Arkansas Agriculture Department the  
 2 following:

3 (A) Effective July 1, 2019, the balance of the appropriation provided  
 4 in Item (A) of Section 3 of Act 39 of 2018, for construction of New Office  
 5 Space, Laboratories and Support Facilities for the Department of Agriculture,  
 6 in a sum not to exceed .....\$60,000,000.  
 7

8 SECTION 4. REAPPROPRIATION - NATURAL AND CULTURAL RESOURCES COUNCIL -  
 9 STATE OWNED LANDS OR HISTORIC SITES. There is hereby appropriated, to the  
 10 Arkansas Agriculture Department, to be payable from the Arkansas Natural and  
 11 Cultural Resources Grant and Trust Fund, for the Arkansas Agriculture  
 12 Department the following:

13 (A) Effective July 1, 2019, the balance of the appropriation provided  
 14 in Section 23 of Act 217 of 2018, for the acquisition, management,  
 15 stewardship or preservation of state owned lands, historic sites, buildings,  
 16 structures or objects, in a sum not to exceed .....\$1,000,000.  
 17

18 SECTION 5. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
 19 obligations otherwise incurred in relation to the project or projects  
 20 described herein in excess of the State Treasury funds actually available  
 21 therefor as provided by law. Provided, however, that institutions and  
 22 agencies listed herein shall have the authority to accept and use grants and  
 23 donations including Federal funds, and to use its unobligated cash income or  
 24 funds, or both available to it, for the purpose of supplementing the State  
 25 Treasury funds for financing the entire costs of the project or projects  
 26 enumerated herein. Provided further, that the appropriations and funds  
 27 otherwise provided by the General Assembly for Maintenance and General  
 28 Operations of the agency or institutions receiving appropriation herein shall  
 29 not be used for any of the purposes as appropriated in this act.

30 (B) The restrictions of any applicable provisions of the State  
 31 Purchasing Law, the General Accounting and Budgetary Procedures Law, the  
 32 Revenue Stabilization Law and any other applicable fiscal control laws of  
 33 this State and regulations promulgated by the Department of Finance and  
 34 Administration, as authorized by law, shall be strictly complied with in  
 35 disbursement of any funds provided by this act unless specifically provided  
 36 otherwise by law.

2       SECTION 6. LEGISLATIVE INTENT. It is the intent of the General  
3 Assembly that any funds disbursed under the authority of the appropriations  
4 contained in this act shall be in compliance with the stated reasons for  
5 which this act was adopted, as evidenced by the Agency Requests, Executive  
6 Recommendations and Legislative Recommendations contained in the budget  
7 manuals prepared by the Department of Finance and Administration, letters, or  
8 summarized oral testimony in the official minutes of the Arkansas Legislative  
9 Council or Joint Budget Committee which relate to its passage and adoption.

11       SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General  
12 Assembly, that the Constitution of the State of Arkansas prohibits the  
13 appropriation of funds for more than a one (1) year period; that the  
14 effectiveness of this Act on July 1, 2019 is essential to the operation of  
15 the agency for which the appropriations in this Act are provided, and that in  
16 the event of an extension of the legislative session, the delay in the  
17 effective date of this Act beyond July 1, 2019 could work irreparable harm  
18 upon the proper administration and provision of essential governmental  
19 programs. Therefore, an emergency is hereby declared to exist and this Act  
20 being necessary for the immediate preservation of the public peace, health  
21 and safety shall be in full force and effect from and after July 1, 2019.
