2	SECTION 3. Arkansas Code § 27-14-705, concerning the application for		
3	registration and certificate of title, is amended to add an additional		
4	subsection to read as follows:		
5	(e)(1) As used in this section, "expedited title processing service"		
6	means the expedited review of an applicant's application for certificate of		
7	title.		
8	(2) The Office of Motor Vehicle may provide an expedited title		
9	processing service for a motor vehicle subject to registration and issuance		
10	of a certificate of title under this chapter upon:		
11	(A) The request of the applicant; and		
12	(B) Payment of an expedited title processing service fee		
13	in the amount of ten dollars (\$10.00) in addition to the specified title		
14	application fees required under subsection (c) of this section.		
15	(3) An expedited title processing service request:		
16	(A) Shall be made in person by the applicant at the		
17	Central Revenue Office located at the Charles D. Ragland Taxpayer Services		
18	Center in Little Rock, Arkansas;		
19	(B) Shall require that an applicant submit all the		
20	required registration forms and payment of the certificate of title		
21	application fees and expedited title processing service fee at the time of		
22	application;		
23	(C) Shall not guarantee the issuance of a certificate of		
24	title; and		
25	(D) Shall be completed by the Office of Motor Vehicle		
26	within three (3) business days from the date the applicant submitted the		
27	application.		
28	(4) The expedited title processing service fee collected under		
29	subdivision (e)(2) of this section shall be deposited to the credit of the		
30	Revenue Division of the Department of Finance and Administration in the		
31	Commercial Driver License Fund to be used for system enhancements, including		
32	without limitation for the systems used for processing motor vehicle,		
33	commercial motor carriers, or driver's licenses.
