## Subtitle

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES - GENERAL OPERATIONS. There is hereby  
23 established for the Department of Higher Education for the 2019-2020 fiscal

11 SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EMERGENCY  
13 GRANTS & EXTRA HELP POOL. An Institution of higher education that suffers an  
14 emergency/disaster event resulting in all or a significant portion of campus  
15 operations being interrupted, may request disaster assistance through the  
16 Arkansas Department of Higher Education. Upon the declaration of an  
17 emergency by the Governor, the institution may request, subject to the  
18 recommendation of the Director of the Department of Higher Education and  
19 approval of the Governor, a grant from the Disaster Relief Fund to assist in  
20 returning that campus to operation and/or to a sister campus providing  
21 services to the students from the affected campus. Certified law enforcement  
22 officers employed by an institution of higher education may be granted  
23 jurisdiction at the sister institution, upon agreement of both institutions.  
24 The Department of Higher Education is authorized a pool of 500 extra help  
25 positions for use in such emergency situations. These positions may be  
26 assigned to the campus suffering the disaster event or to a sister campus  
27 providing services to the students from the affected campus. The Governor  
28 may waive the 1,500 hour limit of ACA 6-63-314 on these assigned extra help  
29 pool positions.

30 The provisions of this section shall be in effect only from July 1, ~~2018~~  
31 2019 through June 30, ~~2019~~ 2020.

32

33 SECTION 18. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.  
35 REALLOCATION OF RESOURCES FOR INSTITUTIONS OF HIGHER EDUCATION. Upon  
36 determination by the president or chancellor of an institution of higher

1 education that a reallocation of resources for purposes of reorganization or  
2 consolidation of administrative functions within the institution is necessary  
3 for efficient and effective operations of the institution, the president or  
4 chancellor, with approval of the institution's board of trustees, may have  
5 the authority to transfer positions, appropriations and related funds between  
6 campuses, divisions, branches, and other budgetary units of the institution,  
7 after receiving prior approval of the Legislative Council or Joint Budget  
8 Committee. The transfers of positions, programs, or activities shall be used  
9 for those purposes for which the appropriations were approved by the General  
10 Assembly. The transfers, consolidations, or reorganizations which involve  
11 academic programs shall be reviewed by the Department of Higher Education  
12 prior to submission to the Legislative Council or Joint Budget Committee.  
13 Provided, however, that the institution shall be limited to submitting no  
14 more than two (2) individual transaction transfer requests during any fiscal  
15 year and shall be further limited to no more than five percent (5%) of the  
16 total General Revenue and Special Revenue appropriation, funding, positions  
17 specific to each institution, and no Tobacco Settlement funds or  
18 appropriations may be reallocated pursuant to this section.

19 Determining the maximum number of employees and the maximum amount of  
20 appropriation and general revenue funding for institutions of higher  
21 education each fiscal year is the prerogative of the General Assembly. This  
22 is usually accomplished by delineating such maximums in the appropriation  
23 act(s) for institutions of higher education and the general revenue  
24 allocations authorized for each fund and fund account by amendment to the  
25 Revenue Stabilization law. Further, the General Assembly has determined that  
26 institutions of higher education may operate more efficiently if some  
27 flexibility is provided to institutions of higher education authorizing broad  
28 powers under this section. Therefore, it is both necessary and appropriate  
29 that the General Assembly maintain oversight by requiring prior approval of  
30 the Legislative Council or Joint Budget Committee as provided by this  
31 section. The requirement of approval by the Legislative Council or Joint  
32 Budget Committee is not a severable part of this section. If the requirement  
33 of approval by the Legislative Council or Joint Budget Committee is ruled  
34 unconstitutional by a court of competent jurisdiction, this entire section is  
35 void.

36 The provisions of this section shall be in effect only from July 1, ~~2018~~

1 2019 through June 30, ~~2019~~ 2020.

3 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LOANS. In  
5 order to provide timely payments under financial aid appropriations made in  
6 this Act, the Chief Fiscal Officer of the State is authorized to provide  
7 loans from the Budget Stabilization Trust Fund to make available all funds  
8 attributable to the financial aid programs under the then current official  
9 revenue estimates. In the event of an unanticipated state revenue shortfall,  
10 any such loans remaining at the end of a fiscal year shall be repaid from  
11 revenues distributed in the first two months of the next fiscal year. Funds  
12 for appropriations made in this Act for purposes other than financial aid  
13 shall not be affected by the application of this provision.

14 The provisions of this section shall be in effect only from July 1, ~~2018~~  
15 2019 through June 30, ~~2019~~ 2020.

16

17 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
18 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORK  
19 FORCE 2000 DEVELOPMENT FUND PROCEDURES. After the amounts to be made  
20 available to the various technical colleges have been determined as set out  
21 in Arkansas Code 26-51-205(d)(2)(A) and 26-51-205(d)(2)(B), such documents as  
22 may be necessary shall be processed so that funds may be transferred from the  
23 Work Force 2000 Development Fund to the State Treasury fund or fund account  
24 from which the technical college draws its general revenue support. Such  
25 funds as may be transferred shall not exceed 93.691% of the total funds  
26 available from the Work Force 2000 Development Fund during the fiscal year.  
27 In the event that a technical institute or comprehensive lifelong learning  
28 center which receives support from the Work Force 2000 Development Fund as  
29 determined by law transfers or merges into the Arkansas Technical College and  
30 Community College System for which Work Force 2000 Development Fund monies  
31 are determined by law, then the actual amount of support from the Work Force  
32 2000 Development Fund in the preceding fiscal year for such educational  
33 institution shall be made available irrespective of any other provision of  
34 law which sets out maximum levels of support from such fund.

35 The funds distributed under Arkansas Code 26-51-205(d)(2)(C) in excess of  
36 those amounts collected and distributed prior to June 30, 2014 shall be

1 deposited into the Skills Development Fund to be used only for personal  
2 services, grants, operation, support, and improvement of occupational,  
3 vocational, technical, and workforce development programs by the Department  
4 of Career Education - Office of Skills Development. The distributions of  
5 funds under Arkansas Code 26-51-205(d)(2)(C) in excess of those amounts  
6 collected and distributed prior to June 30, 2014 shall not apply to proceeds  
7 allocated to schools, colleges and educational institutions under Arkansas  
8 Code 26-51-205(d)(2)(A) and 26-51-205(d)(2)(B).

9 The provisions of this section shall be in effect only from July 1, ~~2018~~  
10 2019 through June 30, ~~2019~~ 2020.

11  
12 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
13 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BUILDING  
14 MAINTENANCE FUND. After the sum of \$13,200,000 has been deposited into the  
15 Higher Education Building Maintenance Fund, any additional deposits are to be  
16 transferred to the Research Development Fund there to be used as provided by  
17 law.

18 The provisions of this section shall be in effect only from July 1, ~~2018~~  
19 2019 through June 30, ~~2019~~ 2020.

20

36 (b)(1) Determining the maximum number of employees, the maximum amount

1 of appropriation, for what purposes an appropriation is authorized, and  
2 general revenue funding for a publicly supported institution of higher  
3 education each fiscal year is the prerogative of the General Assembly.

4 (2) The purposes of subdivision (b)(1) of this section are  
5 typically accomplished by:

6 (A) Identifying the purpose in the appropriation act;

7 (B) Delineating such maximums in the appropriation act for  
8 a publicly supported institution of higher education; and

9 (C) Delineating the general revenue allocations authorized  
10 for each fund and fund account by amendment to the Revenue Stabilization Law,  
11 Arkansas Code § 19-5-101 et seq.

12 (3) It is both necessary and appropriate that the General  
13 Assembly restrict the use of appropriations authorized in the acts of  
14 publicly supported institutions of higher education.

15 (c)(1) Except as provided in this subsection, the publicly supported  
16 institutions of higher education shall not allocate, budget, expend, or  
17 utilize any appropriation authorized by the General Assembly for the purpose  
18 of advertisement, promotion, or other activities designed to promote or  
19 encourage enrollment in the Arkansas Health Insurance Marketplace or the  
20 Arkansas Works Program, including without limitation:

21 (A) Unsolicited communications mailed to potential  
22 recipients;

36 (ii) Educational materials and information

1 distributed under subdivision (c)(2)(C)(i) of this section shall contain only  
2 factual information and shall not contain subjective statements regarding the  
3 coverage for which the potential recipient might be eligible; and

4 (D) Using an Internet website for the exclusive purpose of  
5 enrolling individuals in the Arkansas Health Insurance Marketplace or the  
6 Arkansas Works Program.

7 (d) The publicly supported institutions of higher education shall not  
8 apply for or accept any funds, including without limitation federal funds,  
9 for the purpose of advertisement, promotion, or other activities designed to  
10 promote or encourage enrollment in the Arkansas Health Insurance Marketplace  
11 or the Arkansas Works Program.

12 (e)(1) Except as provided in subdivision (e)(2) of this section, the  
13 publicly supported institutions of higher education shall not:

14 (A)(i) Except as provided in subdivision (e)(1)(A)(ii) of  
15 this section, allocate, budget, expend, or utilize an appropriation  
16 authorized by the General Assembly for the purpose of funding activities of  
17 navigators, guides, certified application counselors, and certified licensed  
18 producers under the Arkansas Health Insurance Marketplace Navigator, Guide,  
19 and Certified Application Counselors Act, Arkansas Code § 23-64-601 et seq.

20 (ii) Subdivision (e)(1)(A)(i) of this section does  
21 not apply to regulatory and training responsibilities related to navigators,  
22 guides, certified application counselors, and certified licensed producers;  
23 and

24 (B) Apply for or accept any funds, including without  
25 limitation federal funds, for the purpose of funding activities of  
26 navigators, guides, certified application counselors, and certified licensed  
27 producers under the Arkansas Health Insurance Marketplace Navigator, Guide,  
28 and Certified Application Counselors Act, Arkansas Code § 23-64-601 et seq.

29 (2) Subdivision (e)(1) of this section does not apply to  
30 certified application counselors at health related institutions, including  
31 without limitation the University of Arkansas for Medical Sciences.

32 (f) An appropriation authorized by the General Assembly shall not be  
33 subject to the provisions allowed through reallocation of resources or  
34 transfer of appropriation authority for the purpose of transferring an  
35 appropriation to any other appropriation authorized for publicly supported  
36 institutions of higher education to be allocated, budgeted, expended, or

10 WORKFORCE CHALLENGE SCHOLARSHIP FUNDS. The Department of Higher Education may  
11 transfer Arkansas Workforce Challenge Scholarship funds to:

12 (1)(A) An Arkansas Academic Challenge Scholarship account in an  
13 amount necessary to fund scholarship awards for nontraditional students for  
14 the 2017-2018 academic year that were not funded due to the limitation on the  
15 scholarship award amount for nontraditional students under § 6-85-  
16 212(e)(2)(A) as it existed before the effective date of this act.

17 (B) The department may distribute scholarship awards to  
18 nontraditional students for the 2017-2018 academic year from funds  
19 transferred under subdivision (1)(A) of this section; and

20 (2)(A) The Office of the Arkansas Lottery in an amount not to  
21 exceed the amount required to fund scholarship awards to be distributed under  
22 § 6-85-201 et seq. for the 2018-2019 or 2019-2020 academic years without  
23 having to draw upon the Scholarship Shortfall Reserve Trust Account under §  
24 23-115-802.

25 (B) If the transfer under subdivision (2)(A) of this

36 SCHOLARSHIP AND GRANT PROMOTION. Of the general revenue that is received by

1 and distributed from the Higher Education Grants Fund Account, the Chief  
2 Fiscal Officer of the State shall transfer two hundred ninety-five thousand  
3 dollars (\$295,000) to the Department of Higher Education Fund Account to be  
4 allocated, budgeted, committed and distributed to the Statewide Scholarship  
5 and Grant Promotion line item in the General Operations section of this act  
6 for the purpose of increasing public awareness of the scholarships and grants

1 the agency for which the appropriations in this Act are provided, and that in  
2 the event of an extension of the legislative session, the delay in the  
3 effective date of this Act beyond July 1, 2019 could work irreparable harm  
4 upon the proper administration and provision of essential governmental  
5 programs. Therefore, an emergency is hereby declared to exist and this Act  
6 being necessary for the immediate preservation of the public peace, health  
7 and safety shall be in full force and effect from and after July 1, 2019.
