14 HEALTHCARE PROFESSIONALS TO AGGRESSIVELY TREAT AN
15 INDIVIDUAL AS SOON AS THE INDIVIDUAL TESTS POSITIVE
16 FOR CORONAVIRUS 2019 (COVID-19).

30 WHEREAS, Arkansas Constitution, Article 6, § 19, provides that, after
31 the General Assembly has disposed of the business set forth in the Governor's
32 proclamation to convene an extraordinary session, the General Assembly may,
33 by a vote of two-thirds of all the members elected to both houses, remain in
34 session for a period not to exceed fifteen (15) days for the purpose of
35 transacting other legislative business; and

1 WHEREAS, the General Assembly has disposed of the matters set forth in
2 the Governor's proclamation calling the First Extraordinary Session of the
3 Ninety-Third General Assembly,

5 NOW THEREFORE,

6 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL
7 ASSEMBLY OF THE STATE OF ARKANSAS:

9 THAT the First Extraordinary Session of the Ninety-Third General
10 Assembly has completed action deemed to be necessary with respect to the
11 business set forth in the Governor's proclamation to convene the
12 extraordinary session.
13

14 BE IT FURTHER RESOLVED THAT the First Extraordinary Session of the
15 Ninety-Third General Assembly is extended in accordance with Arkansas
16 Constitution, Article 6, § 19, and shall remain in session for a period not
17 to exceed fifteen (15) days for the purpose of considering a bill by
18 Representative Bentley to require treatment guides and information about
19 medical research trials to be provided to all individuals who test positive
20 for coronavirus 2019 (COVID-19) and to encourage healthcare professionals to
21 aggressively treat an individual as soon as the individual tests positive for
22 coronavirus 2019 (COVID-19).
