4	SECTION 2. Arkansas Code Title 3, Chapter 8, Subchapter 6, is amended		
5	to add an additional section to read as follows:		
6	3-8-603. Defunct township.		
7	(a) An area within the boundaries of a defunct township that has been		
8	annexed into a wet city or wet incorporated town under Title 14, Chapter 40,		
9	shall have all the rights and privileges of the inhabitants of the annexing		
10	city or annexing incorporated town related to the manufacture or sale of		
11	alcoholic beverages.		
12	(b) An annexed area within a defunct township described under		
13	subsection (a) of this section shall have all ties to the defunct township		
14	related to local option status for the manufacture or sale of alcoholic		
15	beverages severed upon annexation.		
16			
17	SECTION 3. DO NOT CODIFY. RETROACTIVITY. This act applies		
18	retroactively to all defunct townships annexed into a city or incorporated		
19	town before the effective date of this act.
