The Honorable Eddie Joe Williams, State Senator, District 29, was recognized. Senator Williams complimented Ms. Deborah J. Frazier, Chancellor, University of Arkansas Community College at Batesville, and Mr. Roger Rich, Superintendent, Southside School District, as well as students and a former student who related personal histories pertinent to *Project Future Story*, in a presentation at the September 12 meeting. Senator Williams stated it is important to recognize the efforts and the hard work of these young people who have demonstrated that, with a little encouragement, they can go a long way on their educational journey. He said he appreciated Senator English's efforts in getting them here to tell their stories to the Committees.

The Honorable Jane English, State Senator, District 34, and Chair, Senate Interim Committee on Education, was recognized. Senator English stated the partnership with the whole community was on view at the meeting yesterday.

Report by the Public School Health Services Advisory Committee

Presenter:

Ms. Sandra Prater, Chair, Public School Health Services Advisory Committee, was recognized. Ms. Prater discussed the statutorily required Annual Report of the Arkansas Public School Health Services Advisory

Committee (PSHSAC). She said the Report informs the General Assembly about health issues of Arkansas public school students and how school nursing services can be improved. Utilizing a PowerPoint presentation, Ms. Prater presented an Executive Summary to the Committees. She then walked the Committees through the Report, presenting data exhibited in charts and graphs. She discussed a Brief Summary of PSHSAC Recommendations, Best Practice Recommendations Supported by PSHSAC, PSHSAC Next Steps, Needs of Arkansas Children, Current Status of School Health Services and School Nursing Workforce. She explained Appendices A through J of the Report, which detailed the Public School Health Services Advisory Committee, School Nursing Services based on Student Acuity Level, Delegation and Supervision, Nursing Education and Licensure, Medical Records, Management and Storage of Medications, Facilities for School Health Care, Current Arkansas School Nursing Laws, Attorney General's Opinion No. 2016-028, and a section of the Bureau of Legislative Research (BLR) Report, *The Resource Allocation of Foundation Funding*, dated May 31, 2016, pertinent to Counselors, Nurses, and Other Pupil Support. Ms. Prater stressed the importance of adequate facilities and adequate funding for school nurses for the safety and health of students.

- * importance of having a full-time school nurse on campus to provide immediate services to students, including special needs students,
- * school-based health centers set up on campus to provide medical services,
- * most common medical issues treated in school-based health centers,
- * visiting the Pickle Elementary School, a combination of a school, a community health center, and a library, in Austin, Texas in the early to mid-2000s,
- * foundation funding for nursing in the Matrix and funding from other sources,
- * relationship of mental health issues to toxic stress,
- * carving out funding for nurses from tobacco settlement money,
- * barrier(s) to placing nurses in schools with funds from outside the Matrix.
- * PSHSAC and partners working on integrating nursing care services, healthcare services, and health promotional opportunities on campuses towards the support of overall academic achievement,
- * availability of getting full-time school nurses from the community,
- * breakdown of funding that school districts spend on school nurses,
- * health departments opening satellite offices,
- * private duty nursing and reimbursement,
- * small districts having a school nurse on campus, and
- * using NSLA (National School Lunch Act) money for nurses.

Discussion of Draft Adequacy Report and Related Issues

Presenter:

Ms. Nell Smith, Administrator, Policy Analysis and Research Section, Bureau of Legislative Research, was recognized. Ms. Smith stated the draft of the Adequacy Report distributed at today's meeting is a cleaned-up version of the one distributed at the last meeting. She reminded members of the importance of providing their input on the Report, especially as it relates to the Adequacy Recommendations. She said the finalized version of the Report is due by November 1, 2016, and a draft must be published 14 days before the due date.

Representative Cozart noted that a short meeting, attended by several legislators and representatives from Governor Asa Hutchinson's office, had taken place on the evening of Monday, September 12. He had announced the meeting at the joint meeting of the House and Senate Interim Committees on Education earlier in the day. He said a number of issues related to Adequacy had been discussed, but no action was taken.

The Honorable John W. Walker, State Representative, District 34, was recognized. Representative Walker expressed his concerns about what he perceived as the large and growing inequalities in the state's public education system and the lack of substantive efforts to address these inequalities. Representative Walker stated, as a member of the Committees, his unwillingness to consider the Report in its current format.

Representative Cozart reminded members that the Adequacy Report is a work in progress. He stressed the importance of attending meetings and making contributions to the discussions. He stated that while we will never achieve perfection on adequacy, we can get as close as possible to its attainment.

- : court ruling is for funding to be based on need, and
- : opening up the conversation for input from all legislators.

Mr. Isaac Linam was recognized. He stated that official recommendations are statutorily required to be made by the House and Senate Interim Committees on Education.
