 - (f) As used in this section:
 - (1) "Classified employee" means $\frac{a}{a}$ person employed by a $\frac{a}{b}$ public school district under a written annual contract who is not required to have a teaching license issued by the Department of Education as a condition of employment; and
 - (2) "Teacher" means any a person, including without limitation a superintendent and assistant superintendent, holding a license issued by the State of Arkansas and employed by a <u>public</u> school district in a teaching, instructional, supervisory, administrative, or educational and scientific capacity.
