7 (b) The purpose of the program is to allow students with intellectual
8 disabilities to broaden their career opportunities through education and job
9 training in an inclusive and age-appropriate environment.

11 6-41-702. Definitions.

12 As used in this subchapter:

13 (1) “Approved institution” means a public or private nonprofit
14 institution of higher education located in Arkansas that:

15 (A) Is accredited by the Higher Learning Commission of the
16 North Central Association of Colleges and Schools; and

17 (B) Is approved or seeking approval by the United States
18 Department of Education as a comprehensive transition and postsecondary
19 program;

20 (2)(A) “Arkansas resident” means a recipient or a recipient’s

8 (5) Allow a certificate to be awarded to a student who

15 (a)(1) An institution of higher education that wishes to establish a

20 Building Better Futures High School Program if funding is available.

6 (d) A public high school shall:

7 (1) Provide transportation for an admitted and eligible student
8 to and from the closest approved Building Better Futures High School Program
9 that is located no more than fifty (50) miles from the student's public high
10 school; and

11 (2) Continue to provide activities of daily living skills to
12 eligible students at the public high school campus in addition to other
13 requirements of the student's individualized educational plan.

14 (e) Instructional and support staff for a student attending a Building
15 Better Futures High School Program shall be provided by the institution
16 providing the Building Better Futures High School Program while the student
17 is on the campus of the institution.

18 (f)(1) With regard to the Building Better Futures High School Program,
19 an institution of higher education shall not charge tuition and fees at a
20 higher rate for secondary school students than for other students from the
21 community.

22 (2) The tuition and fees shall be charged to the student's
23 public high school and be proportionate to the student's participation in the
24 Building Better Futures High School Program established by the student's
25 individualized education program.

26 (g) A variety of sources may be used to support the Building Better
27 Futures Program, including the costs associated with tuition and support
28 services.
