2 SECTION 23. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
3 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
4 PROVISION. At the end of each fiscal year, the Chief Fiscal Officer of the
5 State shall authorize the transfer of obligated water, sewer, and solid waste
6 funds, as provided in the appropriation act for the Natural Resources
7 Commission in the appropriation entitled "Water, Sewer and Solid Waste -
8 State", from the Miscellaneous Agencies Fund Account, to the Water, Sewer and
9 Solid Waste Revolving Fund.

10 The provisions of this section shall be in effect only from July 1, ~~2016~~

13 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
14 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
15 FORWARD. At the end of each fiscal year, the Chief Fiscal Officer of the
16 State shall authorize the carry forward of funds to support the amount of
17 obligated grants that are certified by the Natural Resources Commission for
18 Matching Grants in the appropriation entitled "Water Quality Plan
19 Implementation".

20 Any carry forward of unexpended balance of funding as authorized herein, may
21 be carried forward under the following conditions:

22 (1) Prior to June 30, ~~2017~~ 2018 the Agency shall by written statement set
23 forth its reason(s) for the need to carry forward said funding to the
24 Department of Finance and Administration Office of Budget;

25 (2) The Department of Finance and Administration Office of Budget shall
26 report to the Arkansas Legislative Council all amounts carried forward by the
27 September Arkansas Legislative Council or Joint Budget Committee meeting
28 which report shall include the name of the Agency, Board, Commission or
29 Institution and the amount of the funding carried forward from the first
30 fiscal year to the second fiscal year, the program name or line item, the
31 funding source of that appropriation and a copy of the written request set
32 forth in (1) above;

33 (3) Each Agency, Board, Commission or Institution shall provide a written
34 report to the Arkansas Legislative Council or Joint Budget Committee
35 containing all information set forth in item (2) above, along with a written
36 statement as to the current status of the project, contract, purpose etc. for

1 which the carry forward was originally requested no later than thirty (30)
2 days prior to the time the Agency, Board, Commission or Institution presents
3 its budget request to the Arkansas Legislative Council/Joint Budget
4 Committee; and

5 (4) Thereupon, the Department of Finance and Administration shall include
6 all information obtained in item (3) above in the budget manuals and/or a
7 statement of non-compliance by the Agency, Board, Commission or Institution.

8 The provisions of this section shall be in effect only from July 1, ~~2016~~
9 2017 through June 30, ~~2017~~ 2018.

10
11 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
12 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
13 FORWARD. At the end of the fiscal year, the Chief Fiscal Officer of the
14 State shall authorize the carry forward of funds to support the amount of
15 obligated grants that are certified by the Natural Resources Commission for
16 Water Quality Technicians in the appropriation entitled "Water Quality Plan
17 Implementation".

18 Any carry forward of unexpended balance of funding as authorized herein, may
19 be carried forward under the following conditions:

20 (1) Prior to June 30, ~~2017~~ 2018 the Agency shall by written statement set
21 forth its reason(s) for the need to carry forward said funding to the
22 Department of Finance and Administration Office of Budget;

23 (2) The Department of Finance and Administration Office of Budget shall
24 report to the Arkansas Legislative Council all amounts carried forward by the
25 September Arkansas Legislative Council or Joint Budget Committee meeting
26 which report shall include the name of the Agency, Board, Commission or
27 Institution and the amount of the funding carried forward from the first
28 fiscal year to the second fiscal year, the program name or line item, the
29 funding source of that appropriation and a copy of the written request set
30 forth in (1) above;

31 (3) Each Agency, Board, Commission or Institution shall provide a written
32 report to the Arkansas Legislative Council or Joint Budget Committee
33 containing all information set forth in item (2) above, along with a written
34 statement as to the current status of the project, contract, purpose etc. for
35 which the carry forward was originally requested no later than thirty (30)
36 days prior to the time the Agency, Board, Commission or Institution presents

1 its budget request to the Arkansas Legislative Council/Joint Budget
2 Committee; and

3 (4) Thereupon, the Department of Finance and Administration shall include
4 all information obtained in item (3) above in the budget manuals and/or a
5 statement of non-compliance by the Agency, Board, Commission or Institution.

6 The provisions of this section shall be in effect only from July 1, ~~2016~~
7 2017 through June 30, ~~2017~~ 2018.

8
9 SECTION 26. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
10 authorized by this act shall be limited to the appropriation for such agency
11 and funds made available by law for the support of such appropriations; and
12 the restrictions of the State Procurement Law, the General Accounting and
13 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
14 Procedures and Restrictions Act, or their successors, and other fiscal
15 control laws of this State, where applicable, and regulations promulgated by
16 the Department of Finance and Administration, as authorized by law, shall be
17 strictly complied with in disbursement of said funds.

18
19 SECTION 27. LEGISLATIVE INTENT. It is the intent of the General
20 Assembly that any funds disbursed under the authority of the appropriations
21 contained in this act shall be in compliance with the stated reasons for
22 which this act was adopted, as evidenced by the Agency Requests, Executive
23 Recommendations and Legislative Recommendations contained in the budget
24 manuals prepared by the Department of Finance and Administration, letters, or
25 summarized oral testimony in the official minutes of the Arkansas Legislative
26 Council or Joint Budget Committee which relate to its passage and adoption.

27
28 SECTION 28. EMERGENCY CLAUSE. It is found and determined by the
29 General Assembly, that the Constitution of the State of Arkansas prohibits
30 the appropriation of funds for more than a one (1) year period; that the
31 effectiveness of this Act on July 1, 2017 is essential to the operation of
32 the agency for which the appropriations in this Act are provided, and that in
33 the event of an extension of the legislative session, the delay in the
34 effective date of this Act beyond July 1, 2017 could work irreparable harm
35 upon the proper administration and provision of essential governmental
36 programs. Therefore, an emergency is hereby declared to exist and this Act

1 being necessary for the immediate preservation of the public peace, health
2 and safety shall be in full force and effect from and after July 1, 2017.
