22	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIRST GENERAL
23	ASSEMBLY OF THE STATE OF ARKANSAS:

25	THAT Senator Bond is authorized to introduce a bill which, as introduced,
26	will read substantially as follows:

28	"For An Act To Be Entitled
29	AN ACT CONCERNING THE POSSESSION AND CARRYING OF A CONCEALED HANDGUN IN ON-
30	CAMPUS COLLEGIATE OR UNIVERSITY HOUSING; AND FOR OTHER PURPOSES.

33	CONCERNING THE POSSESSION AND CARRYING OF A CONCEALED HANDGUN IN ON-CAMPUS
34	COLLEGIATE OR UNIVERSITY HOUSING.

1	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
2	
3	SECTION 1. The lead-in language to Arkansas Code § 5-73-306,
4	concerning the places where possession of a concealed handgun is prohibited,
5	is amended to read as follows:
6	Except as permitted under § 5-73-322(g), a license to carry a concealed
7	handgun issued under this subchapter does not authorize a person to carry a
8	concealed handgun into:
9	
10	SECTION 2. Arkansas Code § 5-73-322(d), concerning storage of a
11	concealed handgun in a university- or college-operated dormitory or residence
12	hall, is amended to read as follows:
13	(d)(1) The storage carrying or possession of a handgun in a nonpublic
14	student room in a university university or college-operated student
15	dormitory or residence hall is prohibited under <u>this section and</u> § $5-73-$
16	119(c).
17	(2)(A) As used in subdivision (d)(1) of this section, "nonpublic
18	student room" means a room in which a student sleeps, keeps his or her
19	personal effects, and either occupies privately or with one (1) or more
20	roommates.
21	(B) "Nonpublic student room" includes a private common
22	area where two (2) or more nonpublic student rooms directly connect to and
23	share a private living space shared by all the connected nonpublic student
24	rooms.
25	
26	SECTION 3. Arkansas Code § 5-73-322(h)(2), concerning the exempted
27	places for a concealed carry licensee with a concealed carry endorsement, is
28	amended to read as follows:
29	(2) Carrying a concealed handgun in a prohibited place listed
30	under $\S 5-73-306(7)-(12)$, (14), (15), and (17), unless otherwise prohibited
31	under this section, § 5-73-306(19), or § 5-73-306(20)."
