22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24	SECTION 1. Arkansas Code Title 7, Chapter 5, Subchapter 2, is amended
25	to add an additional section to read as follows:
26	7-5-213. Notice of special election.
27	(a)(1)(A) Except as provided under subdivision (a)(2) of this section,
28	the county clerk shall mail notice of a special election in the form of a
29	postcard to the registered voters in the county who are eligible to vote in
30	the special election no less than fifteen (15) days before the date of the
31	special election and no more than thirty (30) days before the date of the
32	special election.
33	(B)(i) The postcard under subdivision (a)(1)(A) of this
34	section shall be mailed to the address listed on the voter registration
35	document.
36	(ii) The county clerk is not required to send

1	multiple postcards to the same address when more than one (1) registered
2	voter resides at the address listed on the voter registration document.
3	(2) Notice under this section is not required if the special election
4	<u>is:</u>
5	(A) To fill a vacancy;
6	(B) Initiated by gathering a sufficient number of elector
7	signatures;
8	(C) A statewide election; or
9	(D) Is to be held on the same date as the statewide
10	primary or general election.
11	(b) The notice shall state:
12	(1) The purpose of the special election;
13	(2) The date of the special election; and
14	(3) The official website address of the county clerk where
15	additional information concerning the special election will be posted under
16	subsection (c) of this section.
17	(c) In addition to the notice in subdivision (a)(1) of this section,
18	the county clerk shall post and make available the following information on
19	the official website of the county clerk:
20	(1) The full text of all measures on the ballot, if any;
21	(2) The time and location of the opening, processing,
22	canvassing, and counting of ballots;
23	(3) If early voting locations will be opened, the places and
24	times for early voting;
25	(4) The locations of polling sites for holding the special
26	election in the county;
27	(5) The hours of voting on the special election day;
28	(6) The candidates and offices to be elected at that time, if
29	any;
30	(7) A sample ballot;
31	(8) Instructions on how to vote;
32	(9) General information on voting rights under applicable
33	federal and state laws, including information on the right of an individual
34	to cast a provisional ballot and instructions on how to contact the
35	appropriate officials if any of these rights are alleged to have been
36	violated: and

1	(10) General information on federal and state laws regarding
2	prohibitions on acts of fraud and misrepresentation.
3	(d) All expenses incurred relating to the preparation and mailing of
4	the notice of special elections under this section shall be paid by the
5	entity that sponsors the special election.

7	SECTION 2. Arkansas Code § 7-11-303 is amended to read as follows:
8	7-11-303. Notice.
9	In addition to the publication of the calling document, notice of
10	special elections under this chapter shall be published and posted under §§
11	7-5-202 and , 7-5-206, and 7-5-213.
