20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE	STATE OF ARKANSAS:

22	SECTION 1. Arkansas Code Title 4 is am	ended to add an additional
23	chapter to read as follows:	
24	Chapter 118 - Dog and Cat Sale	e Registration Act
25		
26	4-118-101. Title.	
27	This chapter shall be known and may be	cited as the "Dog and Cat Sale
28	Registration Act".	
29		
30	4-118-102. Legislative intent.	
31	It is the intent of the General Assembl	y to:
32	(1) Require the registration of	persons who sell dogs or cats,
33	or both; and	
34	(2) Ensure that the citizens of	<u>Arkansas have additional</u>
35	information regarding the persons who sell dogs or cats, or both, within the	
36	State of Arkansas.	

1	
2	4-118-103. Definitions.
3	As used in this chapter:
4	(1) "Casual breeder" means a person who owns three (3) or fewer
5	female dogs or cats for the purpose of breeding and who allows only one (1)
6	breeding per dog or cat per calendar year;
7	(2) "Cat" means a member of the species of the domestic cat,
8	Felis catus;
9	(3) "Commercial breeder" means a person who owns more than three
10	(3) female dogs or cats for the purpose of breeding;
11	(4) "Consumer" means a person who purchases a dog or cat;
12	(5)(A) "Dog" means a member of the species of the domestic dog,
13	Canis lupus familiaris, or resultant hybrids.
14	(B) "Dog" does not include a greyhound racing dog;
15	(6) "Person" means an individual, partnership, firm, joint-stock
16	company, corporation, association, trust, estate, or other legal entity;
17	(7)(A) "Public media" means telephone directories, professional
18	directories, newspapers and other periodicals, radio and television,
19	billboards, and mailed or electronically transmitted written or visual
20	communications that do not involve in-person or direct contact with a
21	specific prospective consumer.
22	(B) "Public media" includes all advertisements made on the
23	internet, any website, or social media;
24	(8)(A) "Sale" means the exchange of a dog or cat, or both,
25	between a seller and a consumer for monetary consideration.
26	(B) "Sale" does not include the exchange of a dog or cat,
27	or both:
28	(i) From an animal shelter, an incorporated humane
29	society, or nonprofit organization that has received a 501(c)(3) designation
30	from the United States Internal Revenue Service and that is dedicated to the
31	care of rescued animals or the care and protection of companion or service
32	animals for a reasonable and described adoption fee; or
33	(ii) As a gift or when money is not exchanged for
34	the consideration of the dog or cat, or both; and
35	(9)(A) "Seller" means a person who is required to register under
36	this subchapter.

1	(B) "Seller" includes a casual breeder and a commercial
2	<u>breeder.</u>
3	
4	4-118-104. Registration of sellers - Renewal of registration.
5	(a)(1) A person who offers or attempts to offer a dog or cat, or both,
6	for sale within this state by advertising through public media shall register
7	as a seller with the Arkansas Agriculture Department.
8	(2) The registration shall include the following:
9	(A) The name of the person;
10	(B) The location of each facility housing dogs or cats, or
11	both, that is owned by or in the care, custody, or control of the person;
12	(C) The name and address of the principal agent of the
13	person;
14	(D) The date the person began to operate as a seller under
15	this subchapter;
16	(E) The number of dogs or cats, or both, kept for the
17	purpose of breeding, offering, or selling any offspring to a consumer; and
18	(F) A certificate of good health from a licensed
19	veterinarian for the dog or cat being sold if requested by the consumer.
20	(3) If the registration is for an entity that offers or attempts
21	to offer for sale a dog or cat, or both, the registration shall reflect the
22	name and position of the individual at the entity under whose direction the
23	registration is prepared and shall be made under oath before a notary public.
24	(b)(l) Each registration is valid for a period of two (2) years.
25	(2) On or before the anniversary date of the original
26	registration, the renewal of the registration by the department is required.
27	(3) If at any time before the required renewal date the
28	information initially reported in the registration changes or requires
29	additions, the changes or additions shall be reported to the department
30	within sixty (60) days of the change or addition.
31	(c)(1) The department shall maintain a list of registered sellers
32	containing all information reported with the initial registration, including
33	the date of registration, and the dates and information provided with all
34	subsequent amendments and renewals of the registration.
35	(2) The department shall:
36	(A) Assign to each registered seller a registration

1	number; and
2	(B) Make the list of registered sellers available to the
3	public on the website of the department.
4	(3) The department shall only publish the name of the registered
5	seller and the registration number of the seller.
6	
7	<u>4-118-105. Fees.</u>
8	(a)(1) The Arkansas Agriculture Department shall require a casual
9	breeder to pay a fee of twenty-five dollars (\$25.00) per year for
10	registration as a seller.
11	(2) The department shall require a commercial breeder to pay a
12	fee of one hundred dollars (\$100) per year for registration as a seller.
13	(b) A fee shall not be required for reports of change or addition.
14	
15	4-118-106. Advertisement in public media.
16	(a) In order to place in public media an advertisement for the sale of
17	a dog or cat, or both, the registration number of the registered seller
18	advertising the sale of the dog or cat, or both, or the registration number
19	of the registered seller selling the dog or cat, or both, shall be included
20	in the advertisement.
21	(b)(1) Except as provided in subdivision (b)(2) of this section,
22	failure by the seller to comply with subsection (a) of this section is a
23	Class C misdemeanor.
24	(2) A seller shall be given a ten-day grace period to become
25	compliant with this section.
26	
27	4-118-107. Prohibition of the sale of dogs or cats in certain places.
28	(a)(1) A person shall not sell, exchange, trade, barter, lease, or
29	display for a commercial purpose a dog or cat on the property of another
30	person without first securing the written permission of the other person.
31	(b) This section does not apply to:
32	(1) The display of dogs or cats by or the adoption of dogs or
33	cats from an animal shelter, a humane society, or other nonprofit
34	organization that has received a 501(c)(3) designation from the United States
35	Internal Revenue Service and that is dedicated to the care of rescued
36	animals;

1	(2) The display of dogs or cats as part of a state or county	
2	fair exhibition, a 4-H program, or similar exhibition or educational program;	
3	(3) The sale, exchange, or trade of dogs that are sold primarily	
4	for use in greyhound racing;	
5	(4) The sale, exchange, or trade of dogs or cats within counties	
6	that have a population of less than twenty thousand (20,000) in a commercial	
7	parking lot; or	
8	(5) A prearranged sale between a seller and a specific	
9	individual consumer.	
10	(c) A person who violates this section is subject to a fine in the	
11	amount of one hundred dollars (\$100).	
12		
13	4-118-108. Failure to register or renew — Criminal penalty.	
14	(a) Failure to register as a seller with the Arkansas Agriculture	
15	Department before the advertisement of the sale of a dog or cat, or both, or	
16	before the sale of a dog or cat, or both, is a Class C misdemeanor.	
17	(b) Failure to renew a registration as a seller before the	
18	advertisement of the sale of a dog or cat, or both, or before the sale of a	
19	dog or cat, or both, is a violation under § 5-1-108.	
20		
21	4-118-109. Disposition of fees and funds.	
22	Fees and funds received under this subchapter shall be deposited into	
23	the Dog and Cat Sale Registration Fund to be used by the Arkansas Agriculture	
24	Department for the administration of this subchapter.	
25		
26	<u>4-118-110. Rules.</u>	
27	The Arkansas Agriculture Department shall promulgate rules necessary to	
28	implement and administer this chapter.	
29		
30	SECTION 2. Arkansas Code Title 19, Chapter 5, Subchapter 12, is	
31	amended to add an additional section to read as follows:	
32	19-5-1258. Dog and Cat Sale Registration Fund.	
33	(a) There is created on the books of the Treasurer of State, the	
34	Auditor of State, and the Chief Fiscal Officer of the State a miscellaneous	
35	fund to be known as the "Dog and Cat Sale Registration Fund".	
36	(b) The fund shall consist of:	

1	(1) Grants made by any person or federal government agency;
2	(2) Fees and penalties collected under the Dog and Cat Sale
3	Registration Act, § 4-118-101 et seq.; and
4	(3) Any other funds authorized or provided by law.
5	(c) The fund shall be used by the Arkansas Agriculture Department to
6	administer the Dog and Cat Sale Registration Act, § 4-118-101 et seq.
