 9 SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
 10 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ~~MATCHING~~  
 11 ~~FUNDS~~ DEPARTMENT OF JUSTICE NON-VICTIM ASSISTANCE GRANTS. The funds  
 12 appropriated in this Act for Department of Justice Non-Victim Assistance  
 13 Matching Grants shall be used for matching funds for administering the  
 14 Federal Grants provided in this Act for the Department of Justice Non-Victim  
 15 Assistance Grants. The Department of Finance and Administration - Management
