16	TO REQUIRE CITIZENSHIP OR LEGAL RESIDENCY
17	FOR LICENSURE AS AN OSTEOPATHIC PHYSICIAN
18	IN THE STATE OF ARKANSAS; AND TO DECLARE
19	AN EMERGENCY.

22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code § 17-91-101(a), concerning the licensing
25	requirements of an osteopathic physician, is amended to read as follows:
26	(a) The Arkansas State Medical Board shall accept for licensure by
27	examination any person who:
28	(1) Is at least twenty-one (21) years of age;
29	(2) Is a citizen or a legal resident of the United States;
30	(3) Is of good moral character;
31	(4) Has not been found guilty of acts constituting
32	unprofessional conduct as defined in the Arkansas Medical Practices Act, §
33	17-95-201 et seq., § 17-95-301 et seq., and § 17-95-401 et seq.;
34	(5) Is a graduate of an osteopathic college of medicine whose
35	course of study has been recognized by the Department of Education of the
36	American Osteopathic Association; and

1	(6) Has completed a one-year internship in a hospital approved
2	by the American Medical Association or the American Osteopathic Association.
3	
4	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
5	General Assembly of the State of Arkansas that the State of Arkansas seeks to
6	license more physicians to serve patients within the state, especially in
7	primary care; that osteopathic physicians can aid in providing needed health
8	care throughout the state; that two (2) osteopathic schools in Arkansas will
9	have their first classes graduating in spring of 2019; that without
10	permitting the status of legal residency to be a requirement to gain
11	licensure as well as citizenship, the number of graduates of these schools
12	who can remain in Arkansas to practice will be limited and that this act is
13	immediately necessary to ensure that graduates of osteopathic schools are
14	able to obtain osteopathic licensure when they complete their education in
15	the spring of 2019 and forthcoming graduates of osteopathic schools and to
16	create a greater availability of osteopathic physicians for the practice of
17	osteopathic medicine in this state to improve the health of the citizens of
18	the State of Arkansas. Therefore, an emergency is declared to exist, and this
19	act being immediately necessary for the preservation of the public peace,
20	health, and safety shall become effective on:
21	(1) The date of its approval by the Governor;
22	(2) If the bill is neither approved nor vetoed by the Governor,
23	the expiration of the period of time during which the Governor may veto the
24	<pre>bill; or</pre>
25	(3) If the bill is vetoed by the Governor and the veto is
26	overridden, the date the last house overrides the veto.
