8 TO PROCLAIM RELIGIOUS FREEDOM DAY.

12 TO PROCLAIM RELIGIOUS FREEDOM DAY.

15 WHEREAS, our country's democracy is rooted in the fundamental truth
16 that all people are created equal and endowed with certain inalienable
17 rights, including life, liberty, and the pursuit of happiness; and

18
19 WHEREAS, the freedom of conscience was highly valued early by
20 individuals seeking religious freedom who settled in the American colonies;
21 the founders of the United States; and Thomas Jefferson, who wrote in his
22 letter to the Society of the Methodist Episcopal Church at New London,
23 Connecticut, dated February 4, 1809: "No provision in our constitution ought
24 to be dearer to man than that which protects the rights of conscience against
25 the enterprises of the civil authority"; and

26
27 WHEREAS, the Virginia Statute for Religious Freedom was drafted by
28 Thomas Jefferson, who considered the Virginia Statute for Religious Freedom
29 to be one of his greatest achievements, enacted on January 16, 1786, and the
30 forerunner to the Free Exercise Clause of the First Amendment to the
31 Constitution of the United States; and

32
33 WHEREAS, the First Amendment to the Constitution of the United States
34 protects the right of individuals to express freely and to act peacefully on
35 their religious beliefs, and also protects individuals from coercion to
36 profess or act on a religious belief to which they do not adhere; and

2 WHEREAS, Thomas Jefferson wrote in 1798 that each right encompassed in
3 the First Amendment to the Constitution of the United States is independent
4 of the other rights described in that amendment, "thereby guarding in the
5 same sentence and under the same words, the freedom of religion, of speech,
6 and of the press insomuch, that whatever violated either, throws down the
7 sanctuary which covers the others"; and in 1822, he wrote that the
8 constitutional freedom of religion is "the most inalienable and sacred of all
9 human rights"; and

10
11 WHEREAS, individuals who have studied United States democracy from an
12 international perspective, including Alexis de Tocqueville, have noted that
13 religion plays a central role in preserving the United States Government
14 because religion provides the moral base required for democracy to succeed;
15 and

16
17 WHEREAS, after quoting George Mason's statement from the Virginia
18 Declaration of Rights that "all men are equally entitled to the free exercise
19 of religion according to the dictates of conscience", President Franklin D.
20 Roosevelt went on to state in a 1935 speech delivered at the University of
21 Notre Dame, "In the conflict of policies and of political systems, which the
22 world today witnesses, the United States has held for its own guidance and
23 for the guidance of other nations if they will accept it, this great torch of
24 liberty of human thought, liberty of human conscience. We will never lower
25 it"; and

26
27 WHEREAS, religious freedom "has been integral to the preservation and
28 development of the United States", and "the free exercise of religion goes
29 hand in hand with the preservation of our other rights", as expressed by
30 President George H.W. Bush in his Presidential Proclamation on Religious
31 Freedom Day in 1993; and

32
33 WHEREAS, "our laws and institutions should not impede or hinder but
34 rather should protect and preserve fundamental religious liberties", as
35 expressed by President William Jefferson Clinton in his remarks accompanying
36 the signing of the Religious Freedom Restoration Act of 1993; and

1 WHEREAS, we "continue to proclaim the fundamental right of all peoples
2 to believe and worship according to their own conscience, to affirm their
3 beliefs openly and freely, and to practice their faith without fear or
4 intimidation", as expressed by President Clinton in his Presidential
5 Proclamation on Religious Freedom Day in 1998; and

6
7 WHEREAS, "Freedom of religion is a fundamental human right that must be
8 upheld by every Nation guaranteed by every Government", as expressed by
9 President Clinton in his Presidential Proclamation on Religious Freedom Day
10 in 1999; and

11
12 WHEREAS, "Religious faith has inspired many of our fellow citizens to
13 help build a better Nation" in which "people of faith continue to wage a
14 determined campaign to meet needs and fight suffering", as expressed by
15 President George W. Bush in his Presidential Proclamation on Religious
16 Freedom Day in 2003; and

17
18 WHEREAS, the principle of religious freedom "has guided our Nation
19 forward" and "is a universal human right to be protected here at home and
20 across the globe," as expressed by President Barack Obama in his presidential
21 proclamations on Religious Freedom Day in 2011 and 2013, respectively; and

22
23 WHEREAS, in *Town of Greece v. Galloway*, 134 S. Ct. 1811 (2013), the
24 United States Supreme Court affirmed that "people of many faiths may be
25 united in a community of tolerance and devotion"; and

26
27 WHEREAS, for countless people of the United States, faith is an
28 integral part of every aspect of daily life and is not limited to their
29 homes, houses of worship, or doctrinal creeds; and

30
31 WHEREAS, the role of religion in the society and public life of the
32 United States has a long and robust tradition,

34 NOW THEREFORE,

35 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL
36 ASSEMBLY OF THE STATE OF ARKANSAS:
