15 TO ACKNOWLEDGE THE IMPORTANCE AND NEED
16 FOR AN INSURER TO PROVIDE COVERAGE FOR
17 ADEQUATE TRANSPORTATION REIMBURSEMENT
18 UNTIL AN INSURED'S DAMAGED MOTOR VEHICLE
19 IS REPAIRED.

22 WHEREAS, every automobile liability insurance policy covering any
23 private passenger motor vehicle issued or delivered in this state is required
24 to provide minimum medical and hospital benefits, income disability, and
25 accidental death benefits to the named insured and members of his or her
26 family residing in the same household injured in a motor vehicle accident, as
27 well as to passengers injured while occupying the insured motor vehicle and
28 to persons other than those occupying another motor vehicle struck by the
29 insured motor vehicle, without regard to fault; and

31 WHEREAS, many insureds do not have adequate transportation after a
32 motor vehicle accident due to the damage to the motor vehicle as a result of
33 the motor vehicle accident and are inconvenienced due to the length of time
34 to repair the damaged motor vehicle and the increasing cost required to
35 obtain adequate transportation; and



1 WHEREAS, an insured is required to obtain adequate transportation
2 without reimbursement of these expenses under the insured's automobile
3 liability insurance policy; and

5 WHEREAS, it is in the best interest of Arkansans that an insurer
6 provide coverage for adequate transportation reimbursement until an insured's
7 damaged motor vehicle is repaired,

9 NOW THEREFORE,

10 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL
11 ASSEMBLY OF THE STATE OF ARKANSAS:

13 THAT, the House of Representatives acknowledge the importance and need
14 for an insurer to provide coverage for adequate transportation reimbursement
15 until an insured's damaged motor vehicle is repaired.
