34	affiant, and that to the best of the affiant's knowledge and belief each
35	signature is genuine and each person signing is a registered voter.

2	concerning the form of a paid canvasser affidavit, is amended to read as

26	signatures on a petition part, is amended to read as follows:
27	(2) The petition lacks the signature, printed name, and residence
28	permanent domicile address of the canvasser or is signed by more than one (1)
29	canvasser;

31	SECTION 8. Arkansas Code § 7-9-601(a), concerning the sponsor's
32	responsibilities in the hiring and training of paid canvassers, is amended to
33	read as follows:
34	(a)(1) A person shall not provide money or anything of value to
35	another person for obtaining signatures on a statewide initiative or
36	referendum petition unless the person receiving the money or item of value

1	meets the requirements of this section.
2	(2) Before a signature is solicited by a paid canvasser the
3	sponsor shall:
4	(A) Provide the paid canvasser with a copy of the most
5	recent edition of the Secretary of State's initiatives and referenda
6	handbook;
7	(B) Explain the Arkansas law applicable to obtaining
8	signatures on an initiative or referendum petition to the canvasser; and
9	(C)(i) Provide a complete list of all paid canvassers'
10	names and current residential addresses the permanent domicile address of
11	each paid canvasser to the Secretary of State.
12	(ii) If additional paid canvassers agree to solicit
13	signatures on behalf of a sponsor after the complete list is provided, the
14	sponsor shall provide an updated list of all paid canvassers' names and
15	current residential addresses the permanent domicile address of each paid
16	<u>canvasser</u> to the Secretary of State.
17	(3) Upon filing the petition with the Secretary of State, the
18	sponsor shall submit to the Secretary of State a:
19	(A) Final list of the names and current residential
20	addresses permanent domicile address of each paid canvasser; and
21	(B) Signature card for each paid canvasser.

23	SECTION 9. Arkansas Code § 7-9-601(d)(2) as amended by Act 376 of
24	2019, concerning disclosures by paid canvassers, is amended to read as
25	follows:
26	(2) The current residence address of the person and the person's
27	permanent domicile address if the person's permanent domicile address is
28	different from the person's current residence address;
