22	SECTION 1. Arkansas Code § 9-27-303, concerning definitions under the		
23	Arkansas Juvenile Code of 1989, is amended to add a new definition to read as		
24	follows:		
25	(67) "Imminent harm" means an act of harm that is a danger:		
26	(A) To the physical, mental, or emotional health of a		
27	<pre>juvenile;</pre>		
28	(B) That is constrained by time; and		
29	(C) That may only be prevented by immediate intervention		
30	by a court.

32	SECTION 2. Arkansas Code § 12-18-103, concerning definitions under the
