20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. DO NOT CODIFY. The purpose of this act is to clarify that	
23	the term "copy" used in the Freedom of Information Act of 1967, § 25-19-101	
24	et seq., includes the ability of a citizen to capture still and moving image.	<u>s</u>
25	through image capture, including still and moving photography and video and	
26	<u>digital recording.</u>

28	SECTION 2. Arkansas Code § 25-19-105(a)(1) and (2), concerning the	
29	examination and copying of public records under the Freedom of Information	
30	Act of 1967, are amended to read as follows:	
31	(a)(l)(A) Except as otherwise specifically provided by this section of	r
32	by laws specifically enacted to provide otherwise, all public records shall	
33	be open to inspection and copying, including without limitation copying	
34	through image capture, including still and moving photography and video and	
35	digital recording, by any citizen of the State of Arkansas during the regular	r
36	business hours of the custodian of the records.	

1	(B) However, access to inspect and copy <u>, including without</u>
2	limitation copying through image capture, including still and moving
3	photography and video and digital recording, public records shall be denied
4	to:
5	(i) A person who at the time of the request has
6	pleaded guilty to or been found guilty of a felony and is incarcerated in a
7	correctional facility; and
8	(ii) The representative of a person under
9	subdivision (a)(1)(B)(i) of this section unless the representative is the
10	person's attorney who is requesting information that is subject to disclosure
11	under this section.
12	(2)(A) A citizen may make a request to the custodian to inspect,
13	copy, including without limitation through image capture, including still and
14	moving photography and video and digital recording, or receive copies of
15	public records.
16	(B) The request may be made in person, by telephone, by
17	mail, by facsimile transmission, by electronic mail, or by other electronic
18	means provided by the custodian.
19	(C) The request shall be sufficiently specific to enable
20	the custodian to locate the records with reasonable effort.
21	
22	SECTION 3. Arkansas Code § 25-19-105(d)(1), concerning the access to
23	public records for examination and copying under the Freedom of Information
24	Act of 1967, is amended to read as follows:
25	(d)(1) Reasonable access to public records and reasonable comforts and
26	facilities for the full exercise of the right to inspect and copy, including
27	without limitation copying through image capture, including still and moving
28	photography and video and digital recording, those records shall not be
29	denied to any citizen.
30	
31	SECTION 4. Arkansas Code § 25-19-105(d)(3)(A), concerning the fee for
32	examination and copying of public records under the Freedom of Information
33	Act of 1967, is amended to add an additional subdivision to read as follows:
34	(v) Except as provided in § 25-19-109, the custodian
35	may not charge a fee for the requestor's inspection or copying, including
36	without limitation copying through image capture, including still and moving

T	photography and video and digital recording, of public records.

3	SECTION 5. Arkansas Code § 25-19-105(f)(4), concerning the denial of
4	the right of examination and copying of public records under the Freedom of
5	Information Act of 1967, is amended to read as follows:
6	(4) If it is necessary to separate exempt from nonexempt
7	information in order to permit a citizen to inspect, copy, including without
8	limitation copying through image capture, including still and moving
9	photography and video and digital recording, or obtain copies of public
10	records, the custodian shall bear the cost of the separation.
