| 18 | SECTION 1. Effective January 1, 1996, upon certification that monies |
| 19 | have been appropriated by local governments, set aside and committed by an |
| 20 | institution of higher education, or received by private donations, the Chief |
| 21 | Fiscal Officer of the State may release funds appropriated for defraying the |
| 22 | cost of a multi-purpose civic center in Sebastian County from time to time on |
| 23 | a dollar for dollar basis to the entities enumerated herein, to be used for |
| 24 | the purposes described herein, provided that a cooperative agreement has been |
| 25 | entered into by a local government entity and an institution of higher |
| 26 | education located in Sebastian County. |

| 28 | SECTION 2. Of the appropriation provided to defray the cost of a multi- |
| | purpose civic center in Sebastian County, one-half shall be in addition to |
| | those projects enumerated in Section 3(A) of Act 1316 of 1995. The remaining |

| 34 | SECTION 3. LEGISLATIVE INTENT. It is the intent of the General |
| | Assembly that any funds disbursed under the authority of the appropriations |
| 16 | generating in this Net shall be in sempliance with the stated measure for which |

1 this Act was adopted, as evidenced by the Agency Requests, Executive 2 Recommendations and Legislative Recommendations contained in the budget 3 manuals prepared by the Department of Finance and Administration, letters, or 4 summarized oral testimony in the official minutes of the Arkansas Legislative 5 Council or Joint Budget Committee which relate to its passage and adoption. 7 SECTION 4. CODE. All provisions of this Act of a general and permanent 8 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 9 Code Revision Commission shall incorporate the same in the Code. 10 11 SECTION 5. SEVERABILITY. If any provision of this Act or the 12 application thereof to any person or circumstance is held invalid, such 13 invalidity shall not affect other provisions or applications of the Act which 14 can be given effect without the invalid provision or application, and to this 15 end the provisions of this Act are declared to be severable. 16 17 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict 18 with this Act are hereby repealed. 19 20 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the 21 Eightieth General Assembly meeting in its First Extraordinary Session, that 22 the Constitution of the State of Arkansas prohibits the appropriation of funds 23 for more than a two (2) year period; that the effectiveness of this Act on 24 passage and approval is essential to the operation of the agency for which the 25 appropriations in this Act are provided, and that in the event of an extension 26 of the Regular Session, the delay in the effective date of this Act beyond 27 passage and approval could work irreparable harm upon the proper 28 administration and provision of essential governmental programs. Therefore, an 29 emergency is hereby declared to exist and this Act being necessary for the 30 immediate preservation of the public peace, health and safety shall be in full 31 force and effect upon passage and approval. /s/ Joint Budget Committee 32 33 APPROVED: 10-19-95 34
