9 "AN ACT TO AMEND ARKANSAS CODE 16-13-2103 AND 16-13-
10 2104 (a) TO CONVERT ONE (1) CIRCUIT JUDGE POSITION TO
11 A CIRCUIT-CHANCERY JUDGE POSITION IN THE THIRTEENTH
12 JUDICIAL DISTRICT; AND FOR OTHER PURPOSES."

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code 16-13-2103 is amended to read as follows:
24 "16-13-2103. Judges and chancellors.

25 (a) The qualified electors of the Thirteenth Judicial District shall
26 elect:

- 27 (1) ~~Two (2) circuit judges~~ One (1) circuit judge;
28 (2) Two (2) chancellors;
29 (3) One (1) circuit-chancery judge, juvenile division; and
30 (4) ~~One (1) circuit-chancery judge~~ Two (2) circuit-chancery
31 judges.

32 (b)(1) The judicial position of circuit judge created by Act 53 of 1873
33 and ~~presently held by Judge John M. Graves, whose term expires in 1998, shall~~
34 be designated as 'Circuit Division 1' is converted to a circuit-chancery judge
35 position and shall be designated as 'Circuit-Chancery Division 5'. The judge
36 of Circuit-Chancery Division 5 shall continue to be responsible for the duties

1 formerly assigned to Circuit Division 1.

2 (2) The judicial position of circuit judge created by Act 27 of
 3 1925 and presently held by Judge David F. Guthrie, whose term expires in 1998,
 4 shall be designated as 'Circuit Division 2'.

5 (c)(1) The judicial position of chancellor created by Act 116 of 1903
 6 and presently held by Judge Hamilton H. Singleton, whose term expires in 1998,
 7 shall be designated as 'Chancery Division 1'.

8 (2) The judicial position of chancellor created by Act 372 of
 9 1923 and presently held by Judge Edward P. Jones, whose term expires in 1998,
 10 shall be designated as 'Chancery Division 2'.

11 (d)(1) The judicial position of circuit-chancery judge, juvenile
 12 division, created by Act 949 of 1989 and presently held by Judge Larry W.
 13 Chandler, whose term expires in 1998, shall be designated as 'Circuit-Chancery
 14 Division 3' for all jurisdictions.

15 (2) This judge shall devote such time as may be required to
 16 perform the duties of judge of the juvenile division, which duties shall be
 17 the primary obligation of the judge, and shall have jurisdiction in law,
 18 equity, and probate to hear other cases as time permits.

19 (e) The judicial position of circuit-chancery judge created by Act 41
 20 of 1995 presently held by Judge Carol Crafton Anthony, whose term expires in
 21 1998, shall have jurisdiction in law, equity, and probate and shall be
 22 designated 'Circuit-Chancery Division 4' in all jurisdictions.

23 (f) If any additional judgeship is created, an additional division
 24 shall be established and the judge shall serve as the judge of the additional
 25 division."

26
 27 SECTION 2. Arkansas Code 16-13-2104 (a) is amended to read as follows:

28 "(a) There shall be four (4) divisions of circuit court and ~~four (4)~~
 29 five (5) divisions of chancery court in the Thirteenth Judicial District of
 30 Arkansas as established in § 16-13-2103."

 32 SECTION 3. All provisions of this Act of a general and permanent nature
 33 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
 34 Revision Commission shall incorporate the same in the Code.

 36 SECTION 4. If any provision of this Act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect
2 other provisions or applications of the Act which can be given effect without
3 the invalid provision or application, and to this end the provisions of this
4 Act are declared to be severable.

5
6 SECTION 5. All laws and parts of laws in conflict with this Act are
7 hereby repealed.

8
9 SECTION 6. EMERGENCY CLAUSE. It is hereby found and determined by the
10 Eighty-second General Assembly that conversion of the Circuit Division 1
11 judgeship of the Thirteenth Judicial District to a circuit-chancery judgeship
12 is immediately necessary to insure the orderly and efficient administration of
13 justice within the Thirteenth Judicial District; that the judge of Circuit
14 Division 1 is the only judge in Columbia County; that converting the judgeship
15 to a circuit-chancery judgeship will greatly improve and streamline the
16 judicial system in Columbia County; and that this act is immediately necessary
17 to more adequately distribute the caseload in the Thirteenth Judicial
18 District. Therefore, an emergency is declared to exist and this act being
19 immediately necessary for the preservation of the public peace, health and
20 safety shall become effective on the date of its approval by the Governor. If
21 the bill is neither approved nor vetoed by the Governor, it shall become
22 effective on the expiration of the period of time during which the Governor
23 may veto the bill. If the bill is vetoed by the Governor and the veto is
24 overridden, it shall become effective on the date the last house overrides the
25 veto.
