24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

26 SECTION 1. APPROPRIATION - OPERATIONS. There is hereby appropriated, to
27 the Arkansas State Game and Fish Commission, to be payable from the Game
28 Protection Fund, for operating expenses of the Arkansas State Game and Fish
29 Commission which shall be supplemental and in addition to those funds
30 appropriated in Section 3 of Act 41 of the First Extraordinary Session of
31 2003, the following:

SECTION 2. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 3. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that funds provided by the General Assembly for the operations of the Arkansas State Game and Fish Commission are, due to unforeseen circumstances, insufficient for the Arkansas State Game and Fish Commission to continue to provide essential governmental services; that the provisions of this act will provide the necessary monies for the Arkansas State Game and Fish Commission to continue such services; and that a delay in the effective date of this Act could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval.

If the bill is neither approved nor vetoed by the Governor, it shall become effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the veto is overridden, it shall become effective on the date the last house overrides the veto.
