12 Human Services for personal services, operating expenses, and programmatic  
13 materials for the Safe Haven Program, in a sum not to exceed.....\$100,000.  
14

15 SECTION 32. REAPPROPRIATION - UAMS CHILD ABUSE/RAPE/DOMESTIC VIOLENCE  
16 COMMISSION GRANT. There is hereby appropriated, to the Department of Finance  
17 and Administration - Disbursing Officer, to be payable from the General  
18 Improvement Fund or its successor fund or fund accounts, for the Department  
19 of Finance and Administration - Disbursing Officer the following:

20 (A) Effective July 1, 2014, the balance of the appropriation provided  
21 in Item (A) Section 84 of Act 1443 of 2013, for a grant to the University of  
22 Arkansas for Medical Sciences - Child Abuse/Rape/Domestic Violence Commission  
23 for grants to Child Advocacy Centers for construction, renovation,  
24 maintenance, purchase of equipment, and personal services and operating  
25 expenses, in a sum not to exceed.....\$100,000.

27 SECTION 33. REAPPROPRIATION - DHS-DIVISION OF DEVELOPMENTAL  
28 DISABILITIES SERVICES GRANT. There is hereby appropriated, to the Department  
29 of Finance and Administration - Disbursing Officer, to be payable from the  
30 General Improvement Fund or its successor fund or fund accounts, for the  
31 Department of Finance and Administration - Disbursing Officer the following:

32 (A) Effective July 1, 2014, the balance of the appropriation provided  
33 in Item (A) Section 85 of Act 1443 of 2013, for a grant to the Department of  
34 Human Services - Division of Developmental Disabilities Services, for grants  
35 to community programs serving developmentally disabled individuals for  
36 personal services and operating expenses, construction, improvements,

1 equipment, renovation, and maintenance expenses, in a sum not to exceed  
2 .....\$10,000.

3  
4 SECTION 34. REAPPROPRIATION - ADHE - HISTORICALLY BLACK COLLEGES AND  
5 UNIVERSITIES SCHOLARSHIP GRANTS. There is hereby appropriated, to the  
6 Department of Finance and Administration - Disbursing Officer, to be payable  
7 from the General Improvement Fund or its successor fund or fund accounts, for  
8 the Department of Finance and Administration - Disbursing Officer the  
9 following:

10 (A) Effective July 1, 2014, the balance of the appropriation provided  
11 in Item (A) Section 86 of Act 1443 of 2013, for a grant to the Department of  
12 Higher Education, for grants for scholarships for Historically Black Colleges  
13 and Universities and for personal services and operating expenses as  
14 determined by the Department of Higher Education for outreach programs to  
15 promote awareness of the scholarships for Historically Black Colleges and  
16 Universities, in a sum not to exceed.....\$185,000.

17  
18 SECTION 35. REAPPROPRIATION - PARTNERS FOR INCLUSIVE COMMUNITIES -  
19 SICKLE CELL ANEMIA TASK FORCE. There is hereby appropriated, to the  
20 Department of Finance and Administration - Disbursing Officer, to be payable  
21 from the General Improvement Fund or its successor fund or fund accounts, for  
22 the Department of Finance and Administration - Disbursing Officer the  
23 following:

24 (A) Effective July 1, 2014, the balance of the appropriation provided  
25 in Item (A) Section 87 of Act 1443 of 2013, for a funding and appropriation  
26 transfer for a grant to the University of Arkansas - Fayetteville - College  
27 of Education and Health Professions for personal services and general  
28 operating expenses of the Partners for Inclusive Communities - Sickle Cell  
29 Anemia Task Force, in a sum not to exceed.....\$100,000.

30  
31 SECTION 36. REAPPROPRIATION - RADIATION THERAPY INSTITUTES GRANT.  
32 There is hereby appropriated, to the Department of Finance and Administration  
33 - Disbursing Officer, to be payable from the General Improvement Fund or its  
34 successor fund or fund accounts, for the Department of Finance and  
35 Administration - Disbursing Officer the following:

36 (A) Effective July 1, 2014, the balance of the appropriation provided

1 in Item (A) Section 88 of Act 1443 of 2013, for a funding and appropriation  
2 transfer for a grant to the Department of Human Services for a grant to  
3 Radiation Therapy Institutes for providing radiation therapy services, in a  
4 sum not to exceed.....\$250,000.

5  
6 SECTION 37. REAPPROPRIATION - FLYING SCHOOL MUSEUMS. There is hereby  
7 appropriated, to the Department of Finance and Administration - Disbursing  
8 Officer, to be payable from the General Improvement Fund or its successor  
9 fund or fund accounts, for the Department of Finance and Administration -  
10 Disbursing Officer the following:

11 (A) Effective July 1, 2014, the balance of the appropriation provided  
12 in Item (A) Section 89 of Act 1443 of 2013, for a funding and appropriation  
13 transfer for a grant to the Department of Arkansas Heritage for grants for  
14 maintenance and operations, construction, repairs and personal services for  
15 flying school museums, in a sum not to exceed.....\$100,000.

16  
17 SECTION 38. REAPPROPRIATION - GRANTS FOR BROADBAND ACTIVITIES. There  
18 is hereby appropriated, to the Department of Finance and Administration -  
19 Disbursing Officer, to be payable from the General Improvement Fund or its  
20 successor fund or fund accounts, for the Department of Finance and  
21 Administration - Disbursing Officer the following:

22 (A) Effective July 1, 2014, the balance of the appropriation provided  
23 in Item (A) Section 90 of Act 1443 of 2013, for a transfer of funding and  
24 appropriation for a grant for the Arkansas Science and Technology Authority  
25 for broadband mapping and other activities that will increase broadband  
26 access and adoption through better data collection and broadband planning, in  
27 a sum not to exceed.....\$1,300,000.

28  
29 SECTION 39. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor  
30 obligations otherwise incurred in relation to the project or projects  
31 described herein in excess of the State Treasury funds actually available  
32 therefor as provided by law. Provided, however, that institutions and  
33 agencies listed herein shall have the authority to accept and use grants and  
34 donations including Federal funds, and to use its unobligated cash income or  
35 funds, or both available to it, for the purpose of supplementing the State  
36 Treasury funds for financing the entire costs of the project or projects

1 enumerated herein. Provided further, that the appropriations and funds  
2 otherwise provided by the General Assembly for Maintenance and General  
3 Operations of the agency or institutions receiving appropriation herein shall  
4 not be used for any of the purposes as appropriated in this act.

5 (B) The restrictions of any applicable provisions of the State Purchasing  
6 Law, the General Accounting and Budgetary Procedures Law, the Revenue  
7 Stabilization Law and any other applicable fiscal control laws of this State  
8 and regulations promulgated by the Department of Finance and Administration,  
9 as authorized by law, shall be strictly complied with in disbursement of any  
10 funds provided by this act unless specifically provided otherwise by law.

11  
12 SECTION 40. LEGISLATIVE INTENT. It is the intent of the General  
13 Assembly that any funds disbursed under the authority of the appropriations  
14 contained in this act shall be in compliance with the stated reasons for  
15 which this act was adopted, as evidenced by the Agency Requests, Executive  
16 Recommendations and Legislative Recommendations contained in the budget  
17 manuals prepared by the Department of Finance and Administration, letters, or  
18 summarized oral testimony in the official minutes of the Arkansas Legislative  
19 Council or Joint Budget Committee which relate to its passage and adoption.

20  
21 SECTION 41. EMERGENCY CLAUSE. It is found and determined by the  
22 General Assembly, that the Constitution of the State of Arkansas prohibits  
23 the appropriation of funds for more than a one (1) year period; that the  
24 effectiveness of this Act on July 1, 2014 is essential to the operation of  
25 the agency for which the appropriations in this Act are provided, and that in  
26 the event of an extension of the legislative session, the delay in the  
27 effective date of this Act beyond July 1, 2014 could work irreparable harm  
28 upon the proper administration and provision of essential governmental  
29 programs. Therefore, an emergency is hereby declared to exist and this Act  
30 being necessary for the immediate preservation of the public peace, health  
31 and safety shall be in full force and effect from and after July 1, 2014.
