20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 9-28-402(17)(B), concerning the definition
23 of "provisional foster home", is amended to correct and clarify language to
24 read as follows:

25 (B) Conducts a health and safety check, including a
26 ~~central registry~~ Child Maltreatment Central Registry check and either a
27 criminal background check or a check with local law enforcement, of the
28 relative's home or home of the fictive kin; and

30 SECTION 2. Arkansas Code § 9-28-402(17)(C), concerning the definition
31 of "provisional foster home", is amended to include other relatives who may
32 be considered as a provisional foster family to read as follows:

33 (C) Performs a visual inspection of the home of the
34 relative or fictive kin to verify that the relative or fictive kin and the
35 home ~~will~~ meet the standards for opening a regular foster home;

SECTION 3. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.

It is the intent of the General Assembly that:

(1) The enactment and adoption of this act shall not expressly or impliedly repeal an act passed during the regular session of the Ninety-Second General Assembly;

(2) To the extent that a conflict exists between an act of the regular session of the Ninety-Second General Assembly and this act:

(A) The act of the regular session of the Ninety-Second General Assembly shall be treated as a subsequent act passed by the General Assembly for the purposes of:

(i) Giving the act of the regular session of the Ninety-Second General Assembly its full force and effect; and

(ii) Amending or repealing the appropriate parts of the Arkansas Code of 1987; and

(B) Section 1-2-107 shall not apply; and

(3) This act shall make only technical, not substantive, changes to the Arkansas Code of 1987.
