14 SECTION 53. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS
16 STATE MEDICAL BOARD - EDUCATIONAL PROGRAMS. The State Medical Board is hereby
17 authorized to expend from monies authorized herein, \$30 from each licensed
18 physician licensed by the State Medical Board each year to be paid by the
19 State Medical Board to 501(c)(3) Arkansas foundations that have healthcare
20 professionals on their board and provide for identification, treatment and
21 monitoring of healthcare professionals who suffer from alcohol or drug abuse
22 problems, in order to promote the public health and safety and to insure the
23 continued availability of skilled and highly trained medical professionals
24 for the benefit of the public.

25 The provisions of this section shall be in effect only from July 1, ~~2023~~
26 2024 through June 30, ~~2024~~ 2025.

28 SECTION 54. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

30 STATE BOARD OF NURSING - FUNDING TRANSFER. The Arkansas State Board of
31 Nursing may request a fund transfer in an amount not to exceed one hundred
32 thousand dollars (\$100,000) each fiscal year from the State Board of Nursing
33 Fund to the cash in State Treasury fund as determined by the Chief Fiscal
34 Officer of the State to provide funds for the Student Loan Program
35 appropriation provided herein. Upon approval of the Chief Fiscal Officer of
36 the State, the amount requested shall be transferred on his or her books and

1 those of the State Treasurer and the Auditor of State.

7 BOARD OF PODIATRIC MEDICINE - EDUCATIONAL PROGRAMS. The Arkansas Board of
8 Podiatric Medicine is hereby authorized to expend from monies authorized
9 herein, \$10 from each licensed podiatrist licensed by the Arkansas Board of
10 Podiatric Medicine each year to be paid by the Arkansas Board of Podiatric
11 Medicine to 501(c)(3) Arkansas foundations that have healthcare professionals
12 on their board and provide for identification, treatment and monitoring of
13 healthcare professionals who suffer from alcohol or drug abuse problems, in
14 order to promote the public health and safety and to insure the continued
15 availability of skilled and highly trained podiatric professionals for the
16 benefit of the public.

17 The provisions of this section shall be in effect only from July 1, ~~2023~~
18 2024 through June 30, ~~2024~~ 2025.

19
20 SECTION 56. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
21 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
22 ARKANSAS SPINAL CORD COMMISSION - LINE ITEM TRANSFER. Any savings made in the
23 State Appropriation may, after receiving advice and approval of the
24 Department of Finance and Administration, be transferred to the Spinal
25 Treatment Program.

26 The provisions of this section shall be in effect only from July 1, ~~2023~~
27 2024 through June 30, ~~2024~~ 2025.

28
29 SECTION 57. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
30 authorized by this act shall be limited to the appropriation for such agency
31 and funds made available by law for the support of such appropriations; and
32 the restrictions of the State Procurement Law, the General Accounting and
33 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
34 Procedures and Restrictions Act, or their successors, and other fiscal
35 control laws of this State, where applicable, and regulations promulgated by
36 the Department of Finance and Administration, as authorized by law, shall be

1 strictly complied with in disbursement of said funds.

2
3 SECTION 58. LEGISLATIVE INTENT. It is the intent of the General
4 Assembly that any funds disbursed under the authority of the appropriations
5 contained in this act shall be in compliance with the stated reasons for
6 which this act was adopted, as evidenced by the Agency Requests, Executive
7 Recommendations and Legislative Recommendations contained in the budget
8 manuals prepared by the Department of Finance and Administration, letters, or
9 summarized oral testimony in the official minutes of the Arkansas Legislative
10 Council or Joint Budget Committee which relate to its passage and adoption.

11
12 SECTION 59. EMERGENCY CLAUSE. It is found and determined by the
13 General Assembly, that the Constitution of the State of Arkansas prohibits
14 the appropriation of funds for more than a one (1) year period; that the
15 effectiveness of this Act on July 1, 2024 is essential to the operation of
16 the agency for which the appropriations in this Act are provided, and that in
17 the event of an extension of the legislative session, the delay in the
18 effective date of this Act beyond July 1, 2024 could work irreparable harm
19 upon the proper administration and provision of essential governmental
20 programs. Therefore, an emergency is hereby declared to exist and this Act
21 being necessary for the immediate preservation of the public peace, health
22 and safety shall be in full force and effect from and after July 1, 2024.
