There is hereby appropriated, to the Arkansas Department of Emergency Management, to be payable from the Arkansas Public Safety Trust Fund, for disbursements related to costs that enhance, operate, and maintain 911 services in the State of Arkansas, for the fiscal year ending June 30, 2020, the following:
