read as follows:

" SECTION 24. SECTION 1 of Act 276 of 2019 is amended to read as follows:
SECTION 1. REAPPROPRIATION - DEVELOPMENT AND ENHANCEMENT FUNDS. There is
hereby appropriated, to the Arkansas Economic Development Commission, to be
payable from the Development and Enhancement Fund, for the Arkansas Economic
Development Commission the following:

(A) Effective July 1, 2019, the balance of the appropriation provided in
Item (A) of Section 1 of Act 220 of 2018, for a transfer to the Economic
Development Incentive Quick Action Closing Fund, for incentives to attract new
business and economic development to the state, in a sum not to exceed
.....\$20,000,000."

 8 SECTION 24. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND
 10 TRANSFER PROVISION. As requested from time to time by the Director of the
 11 Arkansas Economic Development Commission, the Chief Fiscal Officer may
 12 transfer on his books and those of the State Treasurer and the Auditor of the
 13 State, the sum not to exceed five hundred thousand dollars (\$500,000) from
 14 the Arkansas Economic Development Commission Fund Account to the Minority and
 15 Women-Owned Business Loan Mobilization Revolving Fund, to provide funds for
 16 the Minority and Women-Owned Business Enterprise Loan Mobilization
 17 appropriation herein.

18 The provisions of this section shall be in effect only from July 1, 2018
 19 2019 through June 30, 2019 2020.

21 SECTION 25. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 22 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
 23 FORWARD – MINORITY AND WOMEN-OWNED BUSINESS LOAN MOBILIZATION REVOLVING FUND.
 24 Any unexpended balance of funds for the Minority and Women-Owned Business
 25 Enterprise Loan Mobilization appropriation which remain at the close of each
 26 state fiscal year shall be carried forward to the next state fiscal year to
 27 be used for the same intent and purposes as set forth in law.

28 The provisions of this section shall be in effect only from July 1, 2018
 29 2019 through June 30, 2019 2020.

31 SECTION 26. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 32 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
 33 PROVISION – STATE OPERATIONS. After receiving approval from the Chief
 34 Fiscal Officer of the State and prior review by the Legislative Council or
 35 Joint Budget Committee, the Director of the Arkansas Economic Development
 36 Commission is authorized to transfer appropriation from any line item
