Re: Arkansas Forestry Commission monthly activity report for March 2019

Dear Senator Teague and Representative Jean:

Per Section 42 of Act 841 of the 2018 Regular Session, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council or the Joint Budget Committee when the Legislature is in session. Please find attached the report for March 2019.

The Cooperative Forestry Assistance Act (CFAA) provides the authorities for a broad range of State and Private Forestry programs. As amended by the 2008 Farm Bill, the CFAA requires each State forestry agency to develop a "Statewide Assessment and Strategies for Forest Resources," collectively referred to as State Forest Action Plan. Arkansas' Forest Action Plan was first developed in 2010 and will be updated in 2019. The updated plan will provide an analysis of forest conditions and trends, identify issues and priorities, and outline strategies to ensure healthy trees and forests for future generations.

On March 27th, AFC hosted the following forest stakeholders and listened to their priorities for this plan: Natural Resource Conservation Service, Green Bay Packaging, Domtar, The Nature Conservancy, Weyerhaeuser, AR Natural Resources Commission, AR Natural Heritage Commission, US Forest Service, University of AR Cooperative Extension Service, Highland Pellets, Arkansas Forestry Association, American Forest Foundation, and a representative for Congressman French Hill.

As you can see, AFC works with many partners and stakeholders.

ARKANSAS FORESTRY COMMISSION March 2019 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During March a total of 123 wildfires were suppressed for a total of 2490 acres burned. Ten-year average for the month of March is 245 wildfires for 5404 acres burned.

Rural Fire Protection: Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans, secures firefighting and emergency service equipment from the federal government and administers a federal grant to assist approximately 1,000 fire departments. The RFP shop provides maintenance to property destined for FD's and repairs Arkansas Forestry Commission (AFC) / Arkansas Agriculture Department (AAD) equipment.

March 2019

- 10 Wildland fire training classes were conducted, 56-fire departments represented (160 firefighters), six minority departments and five AFC/AAD personnel in attendance.
- RFP received one scoop loader (valued at \$58,890), two forklifts (valued at \$133,303), two
 generators (valued at \$107,000), three ATV's (valued at \$26,391), two brush trucks (valued
 at \$142,826) and one Freightliner (valued at \$75,553.88)
- There were four Department of Defense (DOD) vehicles issued to FDs, three Freightliners (valued at \$401,815) and one brush truck (valued at \$134,047).
- 888 DOD Recycling Control Point (RCP) items were received for redistribution to FDs and AFC (valued at \$250,358.63) to include defibrillators, spill kits, CPR training aids, fire hose nozzles and anti-vibration gloves.
- The RFP shop completed maintenance on six AFC vehicles and equipment as well as four DOD vehicles.
- RFP provided three interest free loans via the Rural Fire Revolving Loan Fund.

- 2018 VFA Grant: the last of the wildland PPE for the kits has arrived. Delivery will begin in April to the fire departments with a goal of delivering all by the end of the month.
- 2019 Annual Rural Fire Show: Registrations are starting to come in from vendors. Working with Marketing & Communications on flyers and advertisement to fire departments.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas has 82 active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in March:

- Presented National Program Recognition Trophies to four communities
- Participated in a Three-Day United States Forest Service (USFS) Program Review
- Assisted one community with grant paperwork
- Delivered initial program presentations to three communities

Law Enforcement: AAD has the authority to enforce the laws of the State of Arkansas, but primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AAD aggressively seeks prosecution of violators to deter such crimes. AAD investigators and district law enforcement officers opened three dumping, three fire related and ten timber theft cases. They closed two dumping and seven timber theft cases.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 400,849 acres of private land actively enrolled in the Forest Stewardship Program. Landowners that implement practices under their FSP management plans become Certified Forest Stewards. There are 1,243 Forest Stewards owning 278,420 acres in the State.

For March, 16 FSP plans were prepared on 3,246 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC

Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 42 forest management practice plans on 3,238 acres. AFC personnel conducted 53 prescribed burns on 3,580 acres.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- Staff used a drone during a landowner visit to map and determine the scope of damages caused to a pine plantation.
- Southern pine beetle (SPB) traps were set up in southern Arkansas during the last week
 of February. No SPB were captured during the month of March, an early indication that
 risk is not increasing in 2019.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Urban & Community Forestry staff completed:

- Partnered with AR Urban Forestry Council to organize an Arkansas Arbor Day celebration at the Governor's Mansion. Governor and First Lady Hutchinson attended along with representatives from AR Agriculture Dept, AR Natural Heritage Commission, and the AR Urban Forestry Council.
- Partnered with AR Master Gardener Program to provide a two day advanced Master Gardener training on community forestry. 69 Master Gardeners from 21 counties attended the training which included presentations on how trees benefit communities, how communities can effectively manage their trees, tree care, tree protection, and identifying hazardous trees.
- Partnered with AR Urban Forestry Council to conduct Arkansas ReLeaf program in Clinton. 132 native trees were distributed free of charge to residents to replace trees that were killed or damaged by storms and flooding.
- Participated in Arbor Day celebrations in Winslow, Batesville, Melbourne, Bella Vista, and Hot Springs.
- Wrote article about invasive trees for the AR Municipal League City & Town magazine.
- Presented information about native trees and tree care during a gardening workshop hosted by Greene County Master Gardeners in Paragould. About 80 county residents were in attendance.

Reforestation: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and

hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

Reforestation Manager and Tree Improvement Manager represented AFC at the Western Gulf Forest Tree Improvement Coop Executive Meeting in Bossier City LA on March 26 and 27.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Year to date through March 31, there were 697 online orders and 160 paper orders. Total sales of 1,246,750 pine and 5,746,225 hardwood seedlings. Comparatively, in the same period in FY 18, there were 774 online orders and 238 paper orders. Total sales of 1,541,100 pine and 5,157,925 hardwood seedlings.

- Planted 8.95 acres in field 8 and 6.9 acres in field 5 to date for a total of 15.85 acres planted out of approximately 50 acres to be planted
- Pushed up mulch pile
- Began disking fields
- Removed large pine trees next to the shop
- · Cleaned out ditches to improve drainage
- Put pine seed in stratification for 2020 crop

Prepared fields 2,4,5 and 8 for planting

Tree Improvement:

During the month of March, the Bluff City Tree Improvement staff completed the following:

- Pruned top grafts
- Grafted 220 pine in pots
- Checked Hope planting and re-planted seedlings that heaved out of ground from cold temperatures.
- Collected scion material from loblolly pine
- Completed establishment map for Hope planting.
- Began placing bags on pine to isolate flowers for breeding
- Removed double planted stock trees in orchard 1718
- Packed and delivered balance of 3 star containerized loblolly to Baucum
- Removed limbs from orchard 1718 that had been previously pruned
- Collected pollen
- Pollinated flowers

Best Management Practices (BMP): AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

BMP achieved the following in March 2019:

- Checked on contractor process in repair work on Fulton Co. tract.
- Flagged GPS locations on Little River Co. complaint.
- Meet with contractor/timber buyer and attorney on Ouachita Co. complaint from past period.
- Delivered BMP Guidebooks to landowner in Ouachita Co. after request.
- Conducted exams on Weyerhaeuser tracts (3 county area) in western AR for BMP installations with Weyerhaeuser Forester.
- Fire Shelter Refresher training for BMP Coordinator.

Forest Inventory and Analysis (FIA): AFC in cooperation with USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 88 plots for the month of March. We have completed 10% of INV2019.
