Dear Senator Teague and Representative Jean:

The Arkansas Court of Appeals respectfully requests changes to our 2018-19 appropriations bill pursuant to Arkansas Code Annotated Section 16-12-108(f)(1), which reads: "Law clerks for the Court of Appeals shall receive the same salaries as Supreme Court law clerks."

Current salaries for the Supreme Court law clerks are significantly higher than salaries for the Court of Appeals law clerks, despite the requirement of section 16-12-108(f)(1). The lack of parity stems from the 2017 Biennial Session, in which the Court of Appeals followed recommendations of the Office of Personnel Management and classified its law clerks as Grade GS10, while the Supreme Court, in a later filing, classified its law clerks as Grade GS12. The GS12 grade has resulted in higher salaries for Supreme Court law clerks.

In order to achieve equal salaries for our law clerks, the Court of Appeals requests first that our law clerks be upgraded from GS10 to GS12. This change would be reflected as shown below:

Upon receiving the upgrade to GS12, the Court of Appeals requests that our Regular Salaries appropriation be increased by \$233,000. The Regular Salaries change would be reflected as shown below:

The Administrative Office of the Courts (AOC) respectfully requests the following changes be made to its fiscal year 2018-1019 appropriations bill:

- 1. The attached personnel changes reflect a reorganization effort that will require no additional funds from the State Central Services Fund.
- 2. Section 12. Appropriation Court Automation. We are requesting an increase in the operating expense line from \$2,000,000 to \$2,250,000. This again would require no additional funds from the State Central Services Fund. This appropriation is payable from the Judicial Fine Collection Enhancement Fund.
- 3. Insert New Section 14, second attachment. Appropriation Court Automation Enhancement. This request is for operating expenses and other costs associated with the state court automation system by the Administrative Office of the Courts. This appropriation, if approved, would be payable from the State Central Services Fund.
- 4. Section 20. Appropriation Court Security Grants. We are requesting an increase in (04) Security Grants from \$250,000 to \$500,000. This appropriation, if approved, would be payable from the State Central Services Fund.

#### Chairmen:

I am respectfully requesting the following items to be addressed during the upcoming fiscal session of the Arkansas General Assembly.

### **FY18 Supplemental**

I am requesting a supplemental appropriation in the amount of \$50 million for the Property Tax Relief fund in order to ensure smooth and proper redistributions to counties.

#### **FY19 Appropriations**

I am requesting an increase in the appropriation for the Property Tax Relief fund of \$50 million for the FY19 fiscal year for a total of \$300 million in order to ensure the smooth and proper redistribution to counties.

I am also requesting the following change to the Office of Treasurer of State appropriation for fiscal year 2019. I would like to eliminate one of the Q351U Treas Manager V positions and create a new position and title of Treas Chief Information Technology Officer with a line item maximum of \$97,400 and respective increase in Personal Services Matching. Additionally, I would like to reduce ITEM No. (4) (A) Oper. Expense by \$15,545 for new a total of \$1,104,455, and reduce ITEM No. (5) Data Processing Syst/Services by \$15,545 for a new total of \$954,455. These offsets will ensure there is no increase to the overall appropriation for my office nor increase in personnel in FY19. We currently have an open Treas Manager V position, so this would not result in any staff losing their job.

To put in perspective this request, maintenance costs for our Treasury Management System (ARTMS) for FY17 were \$158,848.25 and currently costs through the end of December were \$115,962.50. This would afford us the ability to bring this function internal to the office, ensure dedicated 24 hour monitoring and maintenance, and reduce overall expenses to the taxpayers of Arkansas.

Finally, I am requesting an increase in Section 4. Appropriation-Investment-Cash as follows:

Dear Senator Teague and Representative Jean:

The Arkansas Supreme Court, and the justices individually, were sued by Judge Wendell Griffen in the referenced case. By letter dated October 10, 2017, Governor Hutchinson authorized the justices to employ outside counsel upon the Attorney General's recusal.

Legal fees incurred by the justices are paid from the Supreme Court's Professional Services Appropriation – Char. 10, with an appropriation of \$25,000. Legal fees and expenses in that amount have been paid, and fees and expenses in the amount of \$135,774.62 are outstanding.

I respectfully request that funds be appropriated to pay the outstanding balance of \$135,774.62 and that the account (Professional Services Appropriation – Char. 10) be appropriated an additional \$250,000.00 for the current fiscal year and \$250,000.00 for the next fiscal year.

This request will ensure outstanding invoices are paid and will provide funds to pay future fees and expenses to the extent they are incurred. We are hopeful that this matter will be resolved quickly. If that is the case, we will not use the additional funds requested. I appreciate your consideration.
