Re: Arkansas Forestry Commission monthly activity report for January 2018

Dear Senator Teague and Representative Jean:

Per Section 42 of Act 841 of the 2017 Regular Session, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council or the Joint Budget Committee when the Legislature is in session. Please find attached the report for January 2018.

In 2017, 1,566 wildfires burned 27,549 acres in Arkansas. This is the highest wildfire frequency year since 2012 when 2,148 wildfires burned 34,434 acres. Overall, wildfires were larger in 2017 with an average size of 17.6 acres compared to a 10-year average of 15.5 acres.

2017 was an active wildfire year, which indicates that we have a lot of woody debris on our forest floor. With plenty of fuel, an uncertain drought outlook, and wildfires trending larger in size, Arkansans can expect the possibility of an active wildfire season beginning soon. Forestry crews remain highly trained and well equipped. Residents should always be mindful of safe burning, but should use added caution in the coming year.

The 2018 wildfire outlook, provided by the National Interagency Coordination Center, predicts higher than normal Arkansas wildfire activity from February – April in Northwest Arkansas counties based on predicted drought conditions and forecasts for dry air over the region.

January 2018 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During January, a total of 169 wildfires were suppressed for a total of 2756 acres burned. Ten-year average for the month of January is 148 wildfires for 2244 acres burned.

Search and Rescue Assistance: An AFC crew from Searcy County was dispatched to find a person that was reported to be stranded behind a tree that had fallen across the road at the Richland Creek Campground. The person got out before our crew got there.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments (VFDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

- 30 rural fire departments, (107 firefighters), were provided wildland fire training, including two minority departments and four AFC personnel in attendance.
- RFP received two service trucks (valued at \$238,643.43), one Ford F-550 brush truck (valued at \$54,310.43), one Stewart & Stevenson (valued at \$184,333.00), one commercial generator (valued at \$2,312.00), and one pressure washer (valued at \$11,863.58).
- There were eight Department of Defense (DOD) vehicles and other equipment issued to VFDs including six Freightliners (valued at \$738,434.00), one brush truck (valued at \$15,751.00) and, one service truck (valued at \$32,990.00).
- 245 DOD Recycling Control Point (RCP) items were received for redistribution to VFDs (valued at \$11,442.26) including, FEMA meal kits, flood lights, chemical lights, jackets, leather men's and women's gloves, cargo tie downs, and rescue bars.
- The RFP shop completed maintenance on 14 AFC vehicles and 10 DOD vehicles.
- RFP provided two interest free loans via the Rural Fire Revolving Loan Fund.

- 2017 Wildfire Volunteer Fire (WFVF) Grant update; the leaf blowers and backpack pumps were delivered to RFP. We are currently waiting on bids for the PPE from the State Procurement Office. The price of PPE will determine the number of rakes per kit that we order.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 167 active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in January:

- Delivered National Program Recognition plaques and signage to one new Firewise site
- Delivered initial program presentation to two fire departments
- Delivered risk assessment training to one fire department
- Assisted fire department with creating news release to showcase program activities

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. AFC Investigators and district law enforcement officers opened 5 dumping, 14 fire related, 1 equipment theft/ vandalism, and 6 timber theft cases. They closed 9 fire related, 4 equipment theft/vandalism, 18 timber theft and 7 dumping cases.

An AFC Law Enforcement Investigator attended the Arkansas Continuity of Operations training and attended Arkansas Department of Emergency Management Training.

Another AFC Law Enforcement Investigator assisted Boone County Sheriff's office with a felony unlawful burning case. He also, assisted with a drone incident on a Logan County fire.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 5,034 landowners owning 930,008 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,301 Forest Stewards owning 284,499 acres.

For January, 13 FSP plans were prepared on 900 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 107 rural forestry management plans on 9,070 acres. AFC personnel conducted 31 prescribed burns on 2,959 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Urban forestry has been implementing programs and planning more progress for the future. Staff has attended multiple trainings and new year meetings. Staff attended the Arkansas Municipal League Winter

Conference in Fort Smith. This created 17 new contacts to expand our program. Contacts signed up for either Tree City USA, inventories, or educational programs that we offer. Staff was also able to award six Arkansas communities with sub-awards to better their Urban Forestry program. Urban Forestry has also accepted and started the review process for the Champion Tree Program.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

Southern Pine Beetle

- Though southern pine beetle (SPB) is currently not an issue in Arkansas, it ravaged the national forests of Mississippi in 2017. Preparedness is warranted in Arkansas and neighboring states.
- Thinning overstocked pine forests remains the best prevention against SPB damages.
- AFC is participating in various collaborations to organize statewide readiness in the event of detecting SPB.
- This subject is high priority for the forest health specialist, who is establishing AFC as a key player in monitoring SPB using aerial surveillance.

Reforestation: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

Reforestation Manager attended the Western Gulf Forest Tree Improvement Program (WGFTIP) Steering Committee meeting which was held in Little Rock on January 24. The Steering Committee serves as a Board of Directors for the WGFTIP. This meeting completed AFC's Reforestation Manager's 3-year term.

On January 24, Reforestation Manager and Nursery Manager conducted tour of Nursery for Director of WGFTIP and the Coop's Research Associate.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15, 2017. Through February 1, 2018, there were:

- 636 on line orders and 136 traditional orders
- Total sales of 1,214,400 pine and 5,134,150 hardwood

Comparatively, in the same period in FY 17, there were:

- 445 on line orders and 107 traditional orders
- Total sales of 2,298,500 pine and 4,937,525 hardwood

During the month of January, Baucum Nursery staff completed the following.

- Harvested (lifted) 1,708,750 hardwood seedlings
- Harvested (lifted) 712,700 pine seedlings
- Shipped 1,549,100 hardwood seedlings
- Shipped 222,950 pine seedlings
- Installed new septic line for Pulaski County office

Tree Improvement:

During the month of January, the Bluff City Tree Improvement staff completed the following:

- Finished pruning lower limbs of production trees in orchard 1718
- Finished installing fence and gate at Rosston test site
- Inventoried orchards 1718 & 1720 for grafting
- Packed 12,000, 3 star loblolly pine seedlings for Baucum Nursery customers
- Moved 1,000 pine and 100 water oak rootstock into greenhouse for grafting
- Took soil samples in orchards 1715, 1716, 1717, 1718, 1719, 1720, 1721
- Took needle samples from production orchards 1715 and 1716
- Provided tour of seed orchards at Bluff City for orchard evaluation by Director of Western Gulf Forest Tree Improvement Program

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 75 plots during January. Inventory 2017 is now 89% complete.
