20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the  
23 Arkansas Department of Transportation for the 2021-2022 fiscal year, the  
24 following maximum number of regular employees and the maximum annual salary  
25 for such employees; and no greater salary than that established herein shall  
26 be paid to any employee from appropriations hereinafter made for said  
27 department. The annual salaries to be paid to each employee authorized herein  
28 shall be determined by the State Highway Commission within the limitations as  
29 set out in this section and the funds and the appropriations made available  
30 for such purposes. All positions established herein shall be exempt from the  
31 provisions of the Uniform Personnel Classification and Compensation Act  
32 (Arkansas Code § 21-5-201, et seq.), or its successor, but shall not be  
33 exempt from the provisions of the Regular Salaries Procedures and  
34 Restrictions Act. Provided further that the salaries for the pay period  
35 beginning June 2021 and ending July 2021 can be paid from the salaries and  
36 overtime authorized for the fiscal year ending in June 30, 2022.

30 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. OVERTIME.

31 For the purpose of paying overtime, any portion of the Overtime line item of

32 the Operations appropriation section may be transferred to and be combined

33 with the Regular Salaries line item in the Operations appropriation section

34 at the discretion of the Highway Commission and notice to the Auditor of

35 State and the Director of Finance and Administration. Thereafter, overtime

36 applicable to salaries may be paid from the Regular Salaries line item of the
