AN ACT FOR THE STATE BOARD OF ELECTION COMMISSIONERS APPROPRIATION FOR THE 2021-
2022 FISCAL YEAR.

Amendment No. ___ to House Bill No. 1081

Amend House Bill No. 1081 as originally introduced:

Page 1, line 35, delete “ 2” and insert “2”

And

Page 1 immediately following line 35 please insert new Item No. to read as follows:

“(7) G314C ELECTION ADMIN SUPERVISOR	1	GRADE GS11
(8) G315C ELECTION ADMIN SPECIALIST	<u> 2</u>	GRADE GS09”

And

Page 1, line 36, delete “7” and insert “10”

And

Page 2, line 1, insert a new Section to read as follows:

“ SECTION 2. EXTRA HELP. There is hereby authorized, for the State Board of Election Commissioners for the 2021-2022 fiscal year, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: twenty (20) temporary or part-time employees, when needed, at rates of pay not to exceed

those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.”

And

Page 2, line 10, delete “\$400,122” and insert “\$599,766”

And

Page 2 immediately following line 10 insert a new Item No. to read as follows:

“(02) EXTRA HELP \$100,000”

And

Page 2, line 11, delete “129,267” and insert “185,167”

And

Page 2, line 13, delete “107,810” and insert “162,810”

And

Page 2, line 18, delete “\$647,199” and insert “\$1,057,743”

And

Appropriately renumber the Item No. in Section 2

And

Page 4, insert new Sections immediately following Section 7 to read as follows:

“ SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER. If funds are not available for the State Board of Election

Commissioners to perform their duties, the Director of the State Board of Election Commissioners may from time to time certify to the Chief Fiscal Officer of the State the amount of funds needed and the Chief Fiscal Officer of the State shall transfer the certified amount from the Nonpartisan Filing Fee Fund to the Miscellaneous Agencies Fund for use by the State Board of Election Commissioners.

The provisions of this section shall be in effect only from July 1, 2021 through June 30, 2022.

SECTION 9. SPECIAL LANGUAGE – CODE AMENDMENT. Arkansas Code § 19-5-1225(b)(2), concerning the Nonpartisan Filing Fee Fund, is amended to read as follows:

(2) The fund shall be used to cover the cost of election expenses of the State Board of Election Commissioners as set out in § 7-10-101 et seq. and for personal services and operating expenses for the State Board of Election Commissioners.”

Appropriately renumber all Sections of the bill.
