Amend House Bill No. 1109 as originally introduced:

Page 3, delete line 5 in its entirety and substitute the following:

"(05) BOOKS & SUBSCRIPTIONS 237,940
(06) PROMOTIONAL ITEMS _____ 0"

AND

Page 5, delete line 8 in its entirety and substitute the following:

" (02) GRANTS TO LIBRARIES 200,000
(03) PROMOTIONAL ITEMS _____ 0"

AND

Page 6, insert an additional SECTION immediately following SECTION 9 to read as follows:

" SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State shall establish upon request for the Department of Education - Arkansas State Library a special appropriation line item to be used in the acquisition of promotional items. When the Department of Education - Arkansas State Library wishes to transfer monies from its operating expenses appropriation to the promotional items line, the Arkansas State Library Board shall approve the request and forward it to the Chief Fiscal Officer of the State for processing.

The provisions of this section shall be in effect only from July 1, 2015 through June 30, 2016."

AN ACT FOR THE ARKANSAS GEOGRAPHIC INFORMATION OFFICE APPROPRIATION FOR THE 2015-
 2016 FISCAL YEAR.

Amendment No. ___ to Senate Bill No. 84

Amend Senate Bill No. 84 as originally introduced:

Insert an additional SECTION immediately following SECTION 5 to read as follows:

" SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, OR TEMPORARY LAW. TRANSFER OF CARRY FORWARD. Any unexpended balance of funds remaining on June 30 of each fiscal year in the Miscellaneous Agencies Fund Account for the Arkansas Geographic Information Office, shall be transferred to the Geographic Information Systems Fund to be used for operating and maintaining the Arkansas Spatial Data Infrastructure, creating, updating, maintaining and disseminating framework spatial data as defined by Arkansas Code §15-21-502.

(1) Prior to June 30, 2016 the Agency shall by written statement set forth its reason(s) for the need to carry forward said funding to the Department of Finance and Administration Office of Budget;

(2) The Department of Finance and Administration Office of Budget shall report to the Arkansas Legislative Council all amounts carried forward by the September Arkansas Legislative Council or Joint Budget Committee meeting which report shall include the name of the Agency, Board, Commission or Institution and the amount of the funding carried forward, the program name or line item, the funding source of that appropriation and a copy of the written request set forth in (1) above;

(3) Each Agency, Board, Commission or Institution shall provide a written report to the Arkansas Legislative Council or Joint Budget Committee containing all information set forth in item (2) above, along with a written statement as to the current status of the project, contract, purpose etc. for which the carry forward was originally requested no later than thirty (30) days prior to the time the Agency, Board, Commission or Institution presents its budget request to the Arkansas Legislative Council/Joint Budget Committee; and

(4) Thereupon, the Department of Finance and Administration shall include all information obtained in item (3) above in the biennial budget manuals and/or a statement of non-compliance by the Agency, Board, Commission or

Institution.

The provisions of this section shall be in effect only from July 1, 2015 through June 30, 2016."
