Re: Arkansas Forestry Commission monthly activity report for December 2016

Dear Senator Teague and Representative Jean:

Per Act 59 of the 89th General Assembly, 2015 Fiscal Session, Section 48, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Joint Budget Committee. Please find attached the report for December 2016.

Arkansas's largest Champion Tree, with a Bigness Index of 668.07, is the Bald Cypress. In December, a group of AFC officials and a THV 11 media crew hiked to the tree to re-measure it, as the most recent numbers were from 2004. The group found the tree to be healthy and still growing, having expanded by 7.2 inches in circumference, and six feet in height.

The Arkansas Champion Tree Program highlights the importance of Arkansas forests and engages Arkansans in tree health. The THV 11 Champion Tree feature story helped to personalize forests through the Bald Cypress in the Lower White River Wildlife Refuge, and highlighted the role that AFC foresters and officials play in maintaining forest health and educational forestry programs.

As you can see, we at the AFC enjoy working with Arkansas's forests, public and media partners to ensure Arkansans understand the beauty and wonders of healthy Arkansas forests.

ARKANSAS FORESTRY COMMISSION December 2016 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During December a total of 75 wildfires were suppressed for a total of 1,105 acres burned.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments (VFDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In December 2016, 15 rural fire departments (269 firefighters) were provided wildland fire training. RFP received 3 Freightliners (valued at \$498,669.00) from Department of Defense (DOD). There was one Department of Defense (DOD) vehicle and equipment issued to VFDs including one Freightliner (valued at \$166,223.00). 93 DOD Recycling Control Point (RCP) items were received for redistribution to VFD's (valued at \$2,357.55) including: Work Gloves. FEPP (Federal Excess Personal Property) equipment received include two boats, two trailers and three motors (valued at \$47,842.89), two bumper jacks and one transmission jack (valued at \$1,699.98) for shop use. One FEPP boat (with trailer and two motors) was issued to VFD's (valued at \$47,120.91).

The RFP shop completed maintenance on 10 AFC vehicles and equipment.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 160 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In December Firewise achieved the following:

- 1. Conducted two Initial Presentations and four risk assessment trainings
- 2. Visited 20 communities for annual Firewise visits and new visits
- 3. Finished paperwork for a total of 166 new and renewal Firewise communities for 2016
- 4. Set goals for Firewise 2017

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In December, AFC Investigators and district law enforcement officers opened three dumping, 12 fires, and six timber cases.

AFC Law Enforcement Investigators and Law Enforcement Officers assisted other agencies in Waldron, Mountain View, and Clinton with the Shop with a Cop Programs.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,917 landowners owning 901,819 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,313 Forest Stewards owning 284,560 acres.

For December, eight FSP plans were prepared on 1,918 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 21 rural forestry management plans on 2,045 acres. AFC personnel conducted eight prescribed burns on 252 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

The Beaver Watershed Alliance (BWA) recently completed their urban forestry grant project which was funded through a grant from the USDA Forest Service. The BWA achieved the project goals of their grant by developing a work plan to meet with elected officials, city staff, and community volunteers in cities that did not currently participate in the Tree City USA program. The plan includes educational programming to help the communities learn more about the benefits of urban forestry. It involves outreach and education to community volunteers, leaders, and decision makers. BWA also distributed educational messaging to 11,200 landowning families, established seven urban forestry demonstration sites, and conducted 12 forums that convey forest and urban forest management principles. Five educational programs were provided to the public over a six-month timeframe. The meetings focused on the impact of water quality from anticipated land use changes in the Beaver Lake Watershed. The communities of Elkins, Huntsville, Greenland, Winslow, St. Paul, Goshen and Fayetteville all benefited from the grant. Goshen and Winslow passed tree ordinances and developed tree boards. The Community of Winslow will be awarded Tree City USA this year.

Forest Health: The Forest Health Specialist, Chandler Barton, assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

• The Forest Health Specialist is promoting the use of the Southern Forest Health website. This website, created by Southern Regional Extension Forestry, offers up-to-date information on many forest pests, both invasive and troublesome native pests. This includes insects, fungi, and plants. The website offers webinars on subjects important to southeastern forests.

 Every year since 2003, the Southern Pine Beetle Prevention Program has provided cost-share incentives for practices that prevent bark beetle outbreaks. AFC county foresters signup and monitor landowner projects. Thinning is a proven method to lessen forest health issues and increase long-term economic value. Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Through December 23, there were 420 on line orders and 87 traditional orders for total sales of 2,306,720 pine and 4,750,175 hardwood. Comparatively, in the same period in 2015, there were 418 on line orders and 67 traditional orders for total sales of 1,113,500 pine and 2,684,950 hardwood.

Lifting of seedlings began on December 12. A total of 756,075 seedlings were lifted and packed during the month of December. 548,900 total bare root seedlings were shipped. Baucum received 4,000 containerized shortleaf, 3,000 containerized 3-star loblolly and shipped 1,250 containerized seedlings. They also received 12,266 lbs. of various oak seed.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

In December the Tree Improvement staff did a complete inventory of orchard 1713 which included making I.D. tags. Applied gopher bait in orchards 1718, 1719, 1720 and 1721. Organized grafts to be planted in production orchards and breeding orchards. Bush hogged future water oak orchard site and isolation strips around orchards. Two members of the Tree Improvement staff attended 4-wheeler and UTV training classes.

Reforestation Manager gave a presentation to the Ouachita Chapter of the Society of American Foresters on December 1. The presentation covered tree improvement and seedling production with emphasis on hardwoods.

Reforestation Manager and Nursery Manager hosted a tour of Baucum Nursery for the National Champion Forestry Team for both 4-H and FFA on December 2. The tour was coordinated through Tamera Walkingstick and Kyle Cunningham from the U of A Cooperative Extension Service.

Best Management Practices: Forestry Commission provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

The BMP Coordinator conducted one courtesy exam in Cleburne County with three participants. Participants consisted of two Landowners and the AFC's BMP coordinator. The exam addressed the Arkansas Forestry Commission's BMP Program. The BMP Coordinator provided copies of Arkansas'

BMP Implementation Reports, AFC's manual "BMPs for Water Quality Protection", the water quality complaint process and MOU with ADEQ.

The BMP coordinator represented the Department of Agriculture at the Arkansas Department of Environmental Quality Review of the Assessment of Methodology for the 2018 303 (d) listing cycle. This workgroup is made up of 30 educated and informed individuals invited to provide input. During our first meeting we discussed the Assessment Methodology, General Standards and Biological Integrity. The second meeting we discussed Specific Standards, Turbidity and Dissolved Oxygen (other than continuous data). The group will continue to work into 2017.

Forest Inventory and Analysis: AFC, in cooperation with the USDA Forest Service Southern Research Station, is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

The FIA team completed 50 plots for the month of December. We are 67% complete with the 2016 survey.
