Sec. 1. Regular Salaries . - Authorizes 1494 full-time position(s). Sec. 2. Extra Help - Authorizes ten (10) part-time position(s). Sec. 3. Appropriations - STATE OPERATIONS. - Appropriates \$87,028,168 for FY1; from the Community Correction Fund. Sec. 4. Appropriations - OPERATIONS - SPECIAL REVENUE. - Appropriates \$8,738,390 for FY1; from the Community Correction Revolving Fund Fund. Sec. 5. Appropriations - FEDERAL PROGRAMS. - Appropriates \$438,493 for FY1; from federal funds. Sec. 6. Amendment No. ____ to House Bill No. 1264

Amend House Bill No. 1264 as engrossed, H3/2/15 (version: 3/2/2015 9:25:45 AM):

Insert an additional SECTION immediately following SECTION 20 to read as follows:

" SECTION 21. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. REPORTING REQUIREMENTS. (a) The Department of Correction and the Department of Community Correction shall submit annually to the Joint Performance Review Committee, the Senate Committee on Judiciary, and the House Committee on Judiciary a copy of each department's own rules and policies, including administrative rules, directives, memoranda, and operational and mental health policies, as well as any document intended to supplement any rule or policy;

(b) The Board of Corrections shall submit annually to the Joint Performance Review Committee, the Senate Committee on Judiciary, and the House Committee on Judiciary a copy of all board policies adopted, as well as any document intended to supplement any board policy.

The Provisions of this section shall be in effect only from July 1, 2015 through June 30, 2016."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Department of Community Correction for the 2015-2016 fiscal year, the
24 following maximum number of regular employees.

1 Correction authorizing broad powers under this Section. Therefore, it is
2 both necessary and appropriate that the General Assembly maintain oversight
3 by requiring prior approval of the Legislative Council or Joint Budget
4 Committee as provided by this section. The requirement of approval by the
5 Legislative Council or Joint Budget Committee is not a severable part of this
6 section. If the requirement of approval by the Legislative Council or Joint
7 Budget Committee is ruled unconstitutional by a court of competent
8 jurisdiction, this entire section is void.

9 The provisions of this section shall be in effect only from July 1,
10 2015 through June 30, 2016.

12 SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
13 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. COUNTY
14 JAIL INVOICE SUMMARY. The Departments of Correction and Community
15 Correction, shall at a minimum and on a fiscal year basis, prepare and post
16 on the applicable agency web site, a monthly summary of county jail
17 reimbursement invoices prepared and forwarded to each county sheriff for
18 verification by the Departments and for payment from the County Jail
19 Reimbursement Fund. In addition, the report shall include a summary of
20 invoices returned by each county for payment for previous months within the
21 fiscal year, the amounts paid, and any balances owed. Each fiscal year-end
22 report shall be maintained on the web sites for a period of no less than
23 three (3) years.

24 The provisions of this section shall be in effect only from July 1,
25 2015 through June 30, 2016.

26
27 SECTION 21. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
28 authorized by this act shall be limited to the appropriation for such agency
29 and funds made available by law for the support of such appropriations; and
30 the restrictions of the State Procurement Law, the General Accounting and
31 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
32 Procedures and Restrictions Act, or their successors, and other fiscal
33 control laws of this State, where applicable, and regulations promulgated by
34 the Department of Finance and Administration, as authorized by law, shall be
35 strictly complied with in disbursement of said funds.
