Review of Rule Regarding Special Education Catastrophic Occurrences Fund, Arkansas Department of Education (referred by the Administrative Rules Subcommittee August 21, 2019)

Presenter:

Ms. Courtney Salas-Ford, Deputy General Counsel, Arkansas Department of Education, was recognized. Utilizing a PowerPoint presentation, Ms. Salas-Ford discussed proposed changes to the current Rule. In her review, she presented an historical outline (2003 – 2019) pertinent to the Fund; then discussed the following topics: Funded Appropriation Amounts, Pro Rata Share Received, What is the intent of Special Education High-Cost Funding? Funding sources for students with disabilities, Current Rule; Is this Catastrophic? Why are changes to the Special Education High-Cost Occurrence Fund Rule being proposed? What parts of the existing rule would change? How would an actual claim be affected when applying the proposed rule changes? How does that compare to the current rule? Which is more Catastrophic to a district? How many students are we talking about? Catastrophic Summary Based on 2016-17 Submissions, What is the impact to smaller districts or districts with fewer resources? What would the fiscal impact to districts be? What about the burden to districts associated with each claim submitted? How could this rule change reduce the burden to districts? and, How would the rule revision impact funding for students with the highest-cost needs?
