27	SECTION 1. Arkansas Code Title 21, Chapter 1, Subchapter 6, is amended
28	to add an additional section to read as follows:
29	21-1-610. Office of Government Accountability and Viability.
30	(a) The Office of Government Accountability and Viability is
31	established to administer this subchapter by:
32	(1) Adopting necessary rules governing this subchapter;
33	(2) Providing education and guidance to public employees and
34	public employers on the application of this subchapter;
35	(3) Recommending changes to this subchapter; and

1	(4) Reporting on the operations of the office to the Legislative
2	Council.
3	(b)(1) The office shall be staffed by:
4	(A) One (1) managing attorney; and
5	(B) One (1) office administrator.
6	(2) The managing attorney is selected by a majority vote of the
7	Governor, the President Pro Tempore of the Senate, and the Speaker of the
8	House of Representatives.
. 9	(3) The maximum salary for staff of the office is:
10	(A) Seventy-three thousand seven hundred seventy-six
. 11	dollars (\$73,776) for the managing attorney; and
12	(B) Fifty-three thousand two hundred sixty-four dollars
13	(\$53,264) for the office administrator.
14	(4)(A) Staff of the office are not subject to the Uniform
15	Classification and Compensation Act, § 21-5-201 et seq., but shall receive
16	other state benefits provided for state employees.
17	(B) Staff of the office are not exempt from the Regular

19	(5) Staff of the office shall participate in the Arkansas Public

21	(c) The managing attorney is the head of the office and shall be

1	(4) Filing an annual fiscal year report with the Legislative

3	(5) Filing partial expenditure reports as requested by the
4	Legislative Council.
. 5	(d)(1) The office shall pay its operating expenses by:
6	(A) Monthly transfers from the Department of Finance and
7	Administration deposited into a cash fund outside the state treasury which
8	are derived from partial net state sales and use tax collections from state
9	agencies; or
10	(B) A loan of no more than two hundred fifty thousand
11	dollars (\$250,000) from the Budget Stabilization Trust Fund appropriated by
12	the General Assembly and deposited into a cash fund outside the state
13	treasury and repaid by the office from funds received under subdivision
14	(d)(l)(A) of this section.
15	(2) The managing attorney shall submit an annual budget request
16	in a similar format as the budget manuals prepared by the Department of

18	Committee before the beginning of the fiscal year for approval before

20	(3) The office is not subject to appropriation by the General
21	Assembly except for a loan from the Budget Stabilization Trust Fund for the
22	operation of the office to be expensed from a cash fund appropriation.
· 23	(e) The office is subject to audit by the Division of Legislative
24	<u>Audit.</u>
25	(f) The office shall adopt rules to administer this subchapter.
