Enforce: This Regulation has been in place for years in order to outline the ability for pharmacies to use automation in their practice. Important points in this regulation are made to ensure that whenever automation is utilized that it is able to correctly track legend drugs and controlled substances so that there is accountability in the use of automation. Given the issues the Board of Pharmacy has seen with unproven systems and automation it is important to maintain this regulation for 2 reasons: 1. to allow for the continued use of such systems, 2. to ensure that automation does not become an additional threat to drug diversion.
