<a href="#">HB1027</a>	Eubanks	TO PROHIBIT A SCHOOL DISTRICT FROM USING PUBLIC FUNDS TO PAY A TEACHER'S OR CLASSIFIED EMPLOYEE'S MEMBERSHIP DUES IN A PROFESSIONAL ORGANIZATION.
<a href="#">HB1029</a>	Lowery	TO EXCLUDE PRINCIPALS, ASSISTANT PRINCIPALS, AND CENTRAL OFFICE EMPLOYEES WITH A MULTIYEAR EMPLOYMENT CONTRACT FROM THE DEFINITION OF "TEACHER" UNDER THE TEACHER FAIR DISMISSAL ACT OF 1983.
<a href="#">HB1036</a>	K. Hendren	TO PROHIBIT THE USE BY A STUDENT OF A PORTABLE ELECTRONIC DEVICE IN A PUBLIC SCHOOL; AND TO ESTABLISH A SECURE, DESIGNATED AREA WITHIN A SCHOOL WHERE A STUDENT WILL DEPOSIT HIS OR HER PERSONAL ELECTRONIC DEVICE DURING THE SCHOOL DAY.
<a href="#">HB1044</a>	F. Allen	TO ALLOW A STUDENT TO CHOOSE WHICH GRADE IN WHICH TO TAKE THE COLLEGE AND CAREER READINESS ASSESSMENT.
