### **Summary for Hospice #1-16**

Effective January 1, 2016, Medicaid Hospice Payment Rates were adjusted by the Centers for Medicaid and Medicare Services (CMS). Arkansas Medicaid is updating the Hospice Policy to be in compliance with federal guidance. This rule changes the payment methodology for Routine Home Care (RHC) to implement two rates that will result in a higher base payment for the first 60 days of hospice care and a reduced base payment rate for days thereafter. This also establishes an add-on payment for services provided by a registered nurse or social worker during the last seven days of a beneficiary's life.
