HB1607	Bragg	CONCERNING THE ENFORCEMENT OF LAWS GOVERNING THE USE OF PUBLIC ROADS BY ALL TERRAIN VEHICLES; AND TO PERMIT ENFORCEMENT BY ARKANSAS WILDLIFE OFFICERS.
HB1613	Hickerson	TO CREATE A DRIVER MONITORING PROGRAM ADMINISTERED BY THE OFFICE OF DRIVER SERVICES; AND TO AUTHORIZE THE OFFICE OF DRIVER SERVICES TO FURNISH DRIVER MONITORING REPORTS.
HB1644	Richmond	TO REPEAL THE REQUIREMENT THAT THE STATE HIGHWAY COMMISSION CONSTRUCT, MAINTAIN, AND REPAIR HARD-SURFACED PRINCIPAL VEHICULAR ROADS THAT LEAD TO A MUNICIPAL AIRPORT LOCATED OUTSIDE THE CITY LIMITS OF A MUNICIPALITY.
SB613	Irvin	TO CREATE THE ARKANSAS UNPAVED ROADS PROGRAM ACT; TO PROVIDE GRANTS TO COUNTIES FOR UNPAVED ROAD PROJECTS; AND TO CREATE THE ARKANSAS UNPAVED ROADS PROGRAM FUND.
