HB2622	Glidewell	TO INCREASE THE MINIMUM MOTOR VEHICLE LIABILITY INSURANCE COVERAGE, TO AUTHORIZE THE IMPOUNDMENT OF MOTOR VEHICLES OPERATED WITHOUT LICENSE AND REGISTRATION, AND TO PROVIDE PAYMENT FOR TOWING AND SERVICE CHARGES.
